In addition to these costs of power purchases K.P.L.C. has to meet the costs relating to operation and maintenance and debt service of other existing generating, transmission and distribution facilities. The bulk of the K.P.L.C. costs, which comprise mainly debt service and system expansinn costs, are contracted in hard currencies.

The steep devaluation, this year, of the shilling against the hard currencies, coupled with the high rise in the rate of inflation, has significantly increased the cost of the operations on the power industry to the extent where the revenue generated would be less than the cost of supplying a unit of electricity. would be less than the cost of supplying a unit in electricity. The increases in average electricity prices by 15 per cent effected on 1st April, 1993, and by 16 per cent due to be effected on 1st August, 1993, would partly reduce this financing gap but still result in the price charged being must less than the cost of supply.
