ELECTIONS REGULATIONS, 1992**

**NOTICE OF ELECTION OF MEMBERS OF THE
NATIONAL ASSEMBLY**

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act and Regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives notice that:

- An election is to be held of members to serve in the National Assembly for Makuyu and Hamisi constituencies.
- Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Friday, 24th September, 1993.
- The day for the nomination for the parliamentary election will be Monday, 27th September, 1993 and nomination papers may be delivered by candidates to the returning officer between the hours of eight o'clock in the morning and one o'clock in the afternoon on Monday, 27th September, 1993.
- If the parliamentary election is contested the poll will take place on Tuesday, 12th October, 1993.

**THE LOCAL GOVERNMENT ELECTIONS
(AMENDMENT) RULES, 1992**

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 (3) (b) and (c) of the Local Government Elections Rules, the Electoral Commission gives notice that:

- (a) An election is to be held to determine the councillors to serve in the electoral areas set out in the schedule hereunder.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Friday, 24th September, 1993.
- (c) The day for the nomination of the candidates for councillors will be Monday, 27th September, 1993 and nomination papers, which may be collected from the returning officers in whose jurisdiction the electoral areas fall, may be delivered by candidates to the returning officer concerned at between the hours of eight o'clock in the morning and noon on Monday, 27th September, 1993.

(d) If the local authority election is contested the poll will take place on Tuesday, 12th October, 1993.
