THE CUSTOMS AND EXCISE ACT (Cap. 472)

VARIABLE RATES OF THE IMPORT DUTY

PURSUANT to the Eleventh Schedule to the Customs and Excise Act, the goods specified in the Schedule shall be levied with variable import duty at a rate equivalent to the element of subsidy stated in the Clean Report of Finding issued in relation to the goods by an authorized pre-shipment inspection agency which has entered into a valid contract with the Government of Kenya.

This notice shall come into operation on 10th November, 1994.
