IT IS notified for general information that the 1995 Proficiency Examination for Clerical Officers will be held on Wednesday, 12th and Thursday, 13th April, 1995, in accordance with the provisions of Personnel Circular No. 1 of 12th February, 1990.

SCHEME OF THE EXAMINATION

The examination will consist of three (3) papers composed of eleven (11) subjects, seven (7) of which must be attempted by all candidates unless previously referred. The remaining four (4) subjects are optional; each candidate will be required to attempt only one optional paper making a total of eight (8) subjects.

The details of the examination are as follows:

Part I.—General Paper (3 hrs.; maximum marks: 100).

This paper will consist of the following four separate subjects:

- (a) Business English (1 hr.; maximum marks: 30).
- (b) Organization and functions of Government (50 minutes; maximum marks: 30).
- (c) Current Affairs (20 minutes; maximum marks: 10).
- (d) Elementary Economics (50 minutes; maximum marks: 30).

Paper II.—Civil Service Regulations (various service regulations) (2 hrs.; maximum marks: 100).

Paper III.—Clerical Procedures (3 hrs.; maximum marks: 100).

Part I.—(Compulsory).

- (a) Office Practice (45 minutes; maximum marks: 25).
- (b) Business Calculations (45 minutes; maximum marks: 25).

Paper II.—Civil Service Regulations (various service regulations) (maximum marks: 50).

- (a) General office services.
- (b) Accounts.
- (c) Supply services.
- (d) Personnel practice.

ELIGIBILITY TO ENTER

The requirements for sitting the Proficiency Examination for Clerical Officers are as follows:

- (i) Entry to examination will be restricted to clerical officers who have completed at least four (4) years continuous service in that grade. However, holders of Kenya Advanced Certificate of Education or its equivalent will be eligible for the examination after two (2) years' service.
- (ii) A senior subordinate staff in possession of division IV of the Kenya Certificate of Education or its equivalent shall be allowed to sit for the Proficiency Examination after completion of at least five (5) years' continuous service.

CONDITIONS FOR OBTAINING A PASS

A candidate will be awarded a pass if he passes all the three (3) papers of the examination.

A partial pass will be awarded to a candidate who passes at least two (2) papers.

A candidate will be awarded a pass if he passes the failed paper in two (2) years. If the candidate fails the paper, then he will have to re-sit the whole examination.

EXAMINATION REGISTRATION FEES

Every candidate entering this examination will be required to pay a non-refundable registration fee of KSh. 300 payable to the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, in either crossed Government cheques or banker's cheque. Personal cheques, money/postal orders or cash will not be accepted.

ENTRY FORMS

Candidates must complete and submit the examination entry forms in triplicate, as set out at the "Appendix" to this circular letter, copies of which should be reproduced by each ministry/department as required and the completed entry forms, duly certified correct by the candidate's principal/chief or senior personnel officer and accompanied by the correct registration fees, should be forwarded to the Secretary, Public Service Commission of Kenya, Nairobi, so as to reach him on or before Friday, 3rd February, 1995. Late entries incomplete/wrongly completed or uncertified forms, forms not accompanied by the correct registration fees, and forms from unqualified candidates will automatically be rejected.

It is, therefore, the responsibility of the certifying officer to check and satisfy himself/herself that the information given

is correct in every respect and that the person intending to register for the examination is qualified. Officers who sit and pass the examination while they are not eligible to sit will automatically be disqualified. Candidates will not be allowed to consult any books, files, notes, etc., during the examination progress. Examination question papers and stationery will be supplied to the candidates by this office, through the provincial education officers who will be in charge of examination centres. The provincial education officers will be responsible for the appointment of invigilators and supervisors, the arrangement of the examination venues and return to this office of the candidates' answer scripts, supervisors' observations and any information relevant to the conduct of the examination, etc. The decision of the Public Service Commission of Kenya, in all matters related to the examination, will be final.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time."
