#### THE TRADE DISPUTES ACT

(Cap. 234)

COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 45 of the Trade Disputes Act, the Minister for Labour and Manpower Development—

- (a) revokes the order published under Gazette Notice No. 2520 of 1992; and
- (b) orders every employer who employs not less than five (5) members of the Kenya Quarry and Mine Workers' Union to—

  - (ii) pay, within ten (10) days of the date of deduction, the total sums deducted under item one (1) of the schedule by crossed cheque made payable into the account of the Kenya Quarry and Mine Workers' Union at Barclays Bank of Kenya Limited, Queenway House, P.O. Box 30011, Nairobi;
  - (iii) pay within ten (10) days of the date of deduction, the total sums deducted under item two (2) of the schedule by a crossed cheque made payable into the account of Central Organization of Trade Unions (Kenya), at the Kenya Commercial Bank, Kencom House, P.O. Box 48400, Nairobi;
  - (iv) notify the trade union and the organization, in writing within one (1) month of the payment; and
  - (v) make written returns to the Registrar of Trade Unions within one (1) month of making all the payment to that trade union and the organization.

Deductions

- 1. The sum of  $2\frac{1}{2}$  per cent from the employee's monthly earnings.
  - 2. The sum of five (5) shillings from every employee.






