## INTERPRETATION APPLICATION

THE parties were heard in Nairobi, on 29th October, 1992, 11th May, 12th May, 21st September, 14th December, 1993, 26th May, 21st July, 2nd August, 23rd August and 6th October, 1994, and relied on their written and verbal submissions.

They also called the following witnesses to give evidence on oath in addition to their written and verbal submissions.

*Claimants.*—Leonard Gaitho Keuto, Ezekiel Kang'ethe and John Mwangi Gaitho.

*Respondents.*—Fred Mukayi Bombo, Donald Keith Mather and David Ndungu Kamau.

## RULING

The court announced its award in the above dispute on 22nd January, 1992, and the last two paragraphs of the award stated:

The court awards that the respondents should pay the grievant 12 months salary by way of compensation for wrongful termination of his services and he should also be paid notice pay, leave pay if any and other terminal benefits.

The court directs the respondents to allow the grievant to remove all his personal belongings which are still in the factory.

The claimants have moved the court through an interpretation application on the aforesaid parts of the court award.

The claimants pointed out that after a series of meetings with the respondents there was deadlock on (i) unpaid leave travelling allowance on a *pro rata* basis for the annual leave (ii) unpaid house allowance and (iii) two months pay in lieu of notice. Further the respondents could not trace or find any of the personal belongings including tools which the grievant had left behind when he was dismissed and had not been allowed to enter the factory to collect all his personal items.

The claimants submitted that the grievant was entitled to all the benefits incorporated in the collective agreement which covered all the unionizable employees and as such he was entitled to two months' pay in lieu of notice together with house allowance and leave travelling allowance.

On stools and personal belongings the claimants have lodged a claim to the tune of KSh. 136,548, which amount includes cost of books, clothing, cash and other assorted personal items which they claim are the personal belongings which the grievant left behind in the factory, and for which they would like the respondents either to return them to the grievant or reimburse him with cost thereof.

The respondents position was that the grievant was not entitled to benefits laid down in the collective agreement as he was not unionizable. As such, he was entitled to one month's notice pay only and no house allowance because he was earning a consolidated salary of KSh. 9,000 like all other management staff. The same was the case with leave allowance.

The respondents denied that the grievant left any personal belongings in the factory and that the grievant was making wild claims without any basis, and these were speculative demands merely as the grievant had not mentioned about any of these items during the main hearing of the dispute.

The court must say that apart from the grievant saying that he was locked out and not given an opportunity to remove his personal belongings during his evidence in the main hearing he did not give any details of what these personal belongings were. It was this part of his evidence which prompted the court to state in the award that the respondents should allow the grievant to remove all his personal belongings which are still in the factory. The claimants as a result have demanded from the respondents the grievants personal belongings the details of which appear hereinafter and the cost of which they maintain is KSh. 136,548. The personal belongings listed are tools, books, clothing, cash, and other assorted personal items.

This took the respondents by surprise and indeed the court as well.

The court, however, could not accept the grievants claim in respect of his personal belongings on its face value and ordered him to strickly prove his claim during the hearing of this interpretation application.

This resulted in the court embarking on full-scale hearing to determine this matter with parties calling several witnesses to give evidence on certain matters in addition to their written and verbal submissions. The hearing took a long time as it was bitterly contested at every stage.

The court has considered very carefully the evidence of all witnesses in arriving at its decision.

The evidence of two witnesses, Leonard Gatu Keuto for the claimants and David Ndungu Kamau for the respondents is of great importance as the former was the one who started the engineering store in the factory and the latter who started working as a labourer and has over the years risen to the post of production manager.

The court notes that Keuto is no longer the respondents employee while Mr. Kamau is senior officer in the respondents undertaking. The court has weighed both these points very carefully in evaluating their evidence minutely.

Keuto confirmed that when he started the engineering store in 1980, mechanics were using their own tools and each one had his own tool kit, and that all tools which came from U.S.A., had documents which he received for record purposes. For the local tools purchased he would get hte invoices with the cost.

The grievant produced a handwritten list of tools with the heading "Tool items from Mr. John Gaitho", which list is signed by one Mr. Chege on behalf of the management with the words "seen" written by him dated 22nd March, 1983.

The respondents have maintained that they are not aware of this list.

The court, however, finds that this list corroborates the evidence of Keuto and the court therefore prefers Keuto's evidence to that of Mr. Kamau on the issue of tools.

The court also believes that the grievant had a few books in his office which he used to read in spare time and also as reference books.

As far as tools which he claims he brought from U.S.A., the court has noted the evidence of Mather, the current factory manager that from his experience when workers came from U.S.A. to Wrigley factories they were given some tools as gifts by their fellow workers in America which were not available locally. He, however, said that such tools were the property of Wrigley. There is, however, no evidence that the tools brought from U.S.A. by the grievant were kept in the respondents engineering store as they were considered Wrigley's property. No records were produced to prove it.

As far as tools part of the personal belongings is concerned, the court believes the evidence of the grievant and finds that he did leave his personal tools in the factory.

Now, coming to his other personal belongings, the matter is rather different. These include claims in respect of a suit

which the grievant claims was worth KSh. 25,800, which he had brought from the dry-cleaner and that he also had KSh. 5,000 in cash in his locker.

In addition to these, the grievant claims the following thirteen (13) items costing KSh. 29,975, which he left behind in the factory:

To begin with, the court finds it difficult to believe that an employee would bring such personal items in the factory, cannot expect an employer to look after his private property in the factory which in the first place he had no business to bring in. If they are lost, then they are lost and the respondents cannot be held responsible for that.

The court cannot accept the grievant's evidence as far as these items are concerned and his claim for this must fail.

The grievant has also asserted that his four professional certificates have been lost by the respondents. The court fails to understand why the grievant had kept such documents at his work place. Surely, important documents should be kept at home in a secure place. If these certificates are lost and no copies are available in the respondents records, then the grievant must himself take steps to get certified copies from the institutions which issued them to him.

All in all, the court finds that the grievant is entitled to be compensated for his tools only which were left behind in the factory and which have been lost.

The court finds after carefully studying the various invoices produced in support of their prices and all the surrounding circumstances of this case that the respondents should pay the grievant a sum of his KSh. 54,573, in full and final but if he did surely he brought them at his own risk and settlement of the grievant's claim in respect of all his tools which got lost in the factory.

As far as the items of additional notice pay and unpaid house allowance and unpaid leave travelling allowances are concerned, the respondents interpretation on these items is correct and the grievant's prayers in respect of them are rejected.

The court further directs that the respondents should pay the grievant if not already paid for the days worked, *pro rata* leave earned and due and provident fund benefit on retirement equivalent to half a months pay. (The court believes that this amount has already been paid to him). This the court was told happens to the equal to service pay benefit for fifteen (15) years payable under the CBA.

### IMPORTANT NOTICE TO SUBSCRIBERS TO THE "KENYA GAZETTE"

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplement*, etc.:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain minimum alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

#### EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

##### *Kenya Gazette*

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
