THE LOCAL GOVERNMENT ELECTIONS (AMENDMENT) RULES, 1992

APPOINTMENT OF RETURNING OFFICERS AND DEPUTY RETURNING OFFICERS

IN EXERCISE of the powers conferred by rule 6 (1) of the Local Government Elections (Amendment) Rules, the Electoral Commission appoints the persons named in the first and second columns of the schedule hereto, respectively, to be the returning officers and deputy returning officers for the electoral areas specified in the third column and which are within the relevant constituency specified in the fourth column of the said schedule.

THE NATIONAL ASSEMBLY AND PRESIDENTIAL ELECTIONS ACT

(Cap. 7)

APPOINTMENT OF REGISTRATION AND ASSISTANT REGISTRATION OFFICERS
