THE COMMISSIONS OF INQUIRY ACT

(Cap. 102)

APPOINTMENT OF COMMISSION OF INQUIRY

IN EXERCISE of the powers conferred by section 3 of the Commissions of Inquiry Act, I, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, being of the opinion that it is in the public interest to do so, do appoint a Commission of Inquiry to enquire into the future structure, powers, legal framework, functions, financing and staffling of local authorities at all levels countrywide. The Commission, to report back within a period of three months, will in addition took into the elevation of Mombasa, Kisumu, Nakuru and Eldoret to city status and consider the subdivision of the above cities and Nairobi into boroughs.

THE COMMISSIONS OF INQUIRY ACT

(Cap. 102)

COMMISSION OF INQUIRY

Citation

A Commission to inquire into the future structure, powers, legal framework, functions, financing and staffing of local authorities at all levels countrywide generally and in particular to matters appentaining to it.

Now, therefore, in exercise of the powers conferred upon the President by section 3 of the Commissions of Inquiry Act, 1, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya do direct the commissioners to hold an inquiry with immediate effect.

The terms of reference shall be-

- (a) to enquire into the future structure, powers, legal framework, functions, financing and staffing of local authorities at all levels countrywide;
- (b) look into the elevation of Mombasa, Kisumu, Nakuru, and Eldoret to city status;
- (c) consider the division of Nairobi City Council and the above cities into boroughs;
- (d) to recommend a system that will significantly increase active local community participation in the designing and implementation of development plans;
- (e) examine local authority licences and regulations that inhibit development;
- (f) look into unacceptable practices such as nepotism, misallocation of plots and deliberate disregard of planning regulations:
- (g) to enquire generally or in particular into any other matter pertaining to the foregoing.

In accordance with the provisions of section 7 (1) of the said Act, to report thereon within three (3) months or such further period as may be determined.

And I do direct that William O. Omamo (Dr.), shall be chairman of the Commission and-

And, I do direct that after its commencement, the said inquiry may be held at such times and in such places as the said commissioners may from time to time determine and shall be held in public or in private or partly in public and partly in private as the said commissioners may from time to time determine.
