THE PRESIDENTIAL AND PARLIAMENTARY ELECTIONS REGULATIONS, 1992

Notice of Election of Member of the National Assembly

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act and regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives

- (a) An election is to be held of a member of Parliament to serve in the National Assembly for Kipipiri Constituency.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Wednesday, 16th August, 1995.
- (c) The day for the nomination of candidates for the parliamentary election shall be Thursday, 17th August, 1995, and nomination papers may be delivered by candidates to the returning officer between the hours of eight octock in the morning and one o'clock in the afternoon on Thursday, 17th August, 1995.

(d) If the parliamentary election is contested the poll shall be taken on Monday, 4th September, 1995.

- 1. The attention of candidates and persons subscribing nomination papers is drawn to the provision of part IV of the Parliamentary and Presidential Elections Regulations.

NOTICE OF ELECTION OF COUNCILLORS

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 (3) (b) and (c) of the Local Government Elections Rules, the Electoral Commission gives notice that:

- (a) An election is to be held to determine the councillors to serve in the electoral areas set out in the schedule here-under.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Wednesday, 16th August, 1995.
- (c) The day for the nomination of the candidates for councillors will be Thursday, 17th August, 1995, and nomination papers, which may be collected from the returning officers in whose jurisdiction the electoral areas fall may be delivered by candidates to the returning officer concerned between the hours of eight o'clock in the morning and noon on Thursday, 17th August, 1995.
- (d) If the local authority election is contested the poll will take place on Monday, 4th September, 1995.
