NOTICE OF ELECTION OF MEMBERS OF THE  
NATIONAL ASSEMBLY

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the

National Assembly and Presidential Elections Act, and regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives notice that:

- (a) An election is to be held of members of Parliament to serve in the National Assembly for Nyatike and Siakago constituencies.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Tuesday, 21st November, 1995.
- (c) The day for the nomination of candidates for the parliamentary election shall be Wednesday, 22nd November, 1995, and nomination papers may be delivered to the returning officers between the hours of eight o'clock in the morning and one o'clock in the afternoon on Wednesday, 22nd November, 1995.
- (d) If the parliamentary election is contested the poll shall be taken on Thursday, 7th December, 1995.

NOTICE OF ELECTION OF COUNCILLORS

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 (3) (b) and (c) of the Local Government Elections Rules, the Electoral Commission gives notice that:

- (a) An election is to be held to determine the councillors to serve in the electoral areas set out in the schedule hereunder.

- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Tuesday, 21st November, 1995.

- (c) The day for the nomination of the candidates for councillors will be Wednesday, 22nd November, 1995, and nomination papers which may be collected from the returning officers in whose jurisdiction the electoral areas fall may be delivered to the returning officer concerned between the hours of eight o'clock in the morning and noon on Wednesday, 22nd November, 1995.

- (d) If the local authority election is contested the poll will take place on Thursday, 7th December, 1995.
