NOTICE OF ELECTION OF MEMBER OF THE NATIONAL ASSEMBLY

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act, and regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives notice that:

(a) An election is to be held of a member of Parliament to serve in the National Assembly for Kibwezi Constituency.

(b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Tuesday, 27th February, 1996. (c) The day for the nomination of candidates for the parliamentary election shall be Wednesday, 28th February, 1996 and nomination papers may be delivered to the returning officer between the hours of eight o'clock in the morning and one o'clock in the afternoon on Wednesday, 28th February, 1996.

(d) If the parliamentary election is contested the poll shall be taken on Thursday, 14th March, 1996.

NOTES

1. The attention of candidates and persons subscribing nomination papers is drawn to the provision of part IV of the Parliamentary and Presidential Elections Regulations.

2. A person guilty of an election offence will be liable to the penalties imposed by the Election Offences Act (Cap. 66), and to the disqualifications imposed by the National Assembly and Presidential Elections Act.
