THE LOCAL GOVERNMENT ELECTIONS (AMENDMENT) RULES, 1992

NOTICE OF ELECTION OF COUNCILLORS

IN EXERCISE of the powers conferred by section 42a of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 (3) (b) and (c) of the Local Government Elections Rules, the Electoral Commission gives notice that:

- (a) An election is to be held to determine the councillors to serve in the electoral areas set out in the schedule hereunder.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Tuesday, 27th February, 1996.

(c) The day for the nomination of the candidates for councillors will be Wednesday, 28th February, 1996, and nomination papers, which may be collected from the returning officers in whose jurisdiction the electoral areas fall may be delivered by candidates to the returning officer concerned between the hours of eight o'clock in the morning and noon on Wednesday, 28th February, 1996.

(d) If the local authority election is contested the poll will take place on Thursday, 14th March, 1996.
