THE PRESIDENTIAL AND PARLIAMENTARY ELECTIONS REGULATIONS, 1992

Notice of Election of Members of the National Assembly

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act, and regulations 8 (3) and 14 of the Presidential and Parliamentary Elections Regulations, 1992, the Electoral Commission gives notice that:

- (a) An election is to be held of members of Parliament to serve in the National Assembly for Westlands and Hamisi constituencies.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Thursday, 23rd May, 1996.
- (c) The day for the nomination of candidates for the parliamentary election shall be Friday, 24th May, 1996 and nomination papers may be delivered to the returning officer between the hours of eight o'clock in the morning and one o'clock in the afternoon on Friday, 24th May, 1996.
- (d) If the parliamentary election is contested the poll shall be taken on Monday, 10th June, 1996.

- 1. The attention of candidates and persons subscribing nomination papers is drawn to the provision of part IV of the Parliamentary and Presidential Elections Regulations.
- 2. A person guilty of an election offence will be liable to the penalties imposed by the Election Offences Act (Cap. 66), and to the disqualifications imposed by the National Assembly and Presidential Elections Act.

- (c) The day for the nomination of the candidates for councillors will be Friday, 24th May, 1996 and nomination papers which may be collected from the returning officers in whose jurisdiction the electoral areas fall may be delivered by candidates to the returning officer concerned between the hours of eight o'clock in the morning and noon on Friday, 24th May, 1996.
- (d) If the local authority election is contested the poll will take place on Monday, 10th June, 1996.
