The number of outstanding complaints at the end of this period is one thousand two hundred and fifty-one (1,251)

The first half of this year has seen a 20 per cent increase in the number of complaints compared to the same period for the calendar year 1995. This probably indicates a wider knowledge by the public of the Commission's existence and functions than any marked deterioration in legal services. With a view to expanding its services to the public, the Commission planned visits to provincial headquarters. One visit to Nyanza Province was undertaken in the quarter under review. There we found widespread dissatisfaction with the laws delays (a matter not within the Commission's brief) and also very considerable frustration and anger at the avarice and incompetence of a few unscrupulous advocates

The Commission has designed a "Helpform" to assist complainants to put down in one place all the information they have about their problem. Once again the Commission urges complainants to maximize the use of the existing procedure for a cash account in the courts by vigorous use of Order 52 rule 4, Civil Procedure Rules as amended by Legal Notice No 5 of 1996 and where appropriate by asking judges to discipline advocates under section 56 of the advocates Act

As at 30th June, 1996, the Disciplinary Committee had two hundred and fifty-nine (259) outstanding cases. The performance of the Disciplinary Committee continue to be disappointing especially by failing to master a quorum when both this Commission and the accused advocates are eager to deal with a long list of outstanding complaints

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

#### EXTRACT FROM THE CODE OF REGULATIONS SECTION D—

##### *Kenya Gazette*

"D 40 (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*."

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.
