The circumstances leading to the grievants dismissal happened between 5th and 12th July, 1994, respectively. On 13th July 1994 all the 36 grievants were dismissed for allegedly refusing to work during the period indicated hereinabove

The court finds it extremely unusual that 16 workers were issued with warning letters in a couple of days and when the shop-stewards tried to see the management they were refused access to the managing director. The shop-stewards contacted the claimants whose representative, Mr Mangaya wrote a letter to the respondents telling them he would come and discuss the issue on 12th July 1994 at 10 00 a m

The managing director refused to see Mr Mangaya saying that he was busy. The court notes that the date and time of the meeting had not been mutually arranged

As a result of the managing director's refusal to see the claimants representative who later addressed the workers during lunch break the go-slow started and the subsequent events mentioned hereinabove took place

The crucial point in this whole dispute emerges during the efforts of the Ministry of Labour officials to get the workers back to their jobs. The parties hammered out a return to work formula in the morning of 13th July 1994 and which was signed by the respondents representative. In this return to work formula it was stipulated that workers would resume work and there would be no victimization on either side. In the afternoon however, the respondent's managing director came and ordered his personnel manager to tear the return to work formula and throw it in the waste paper basket

This incident has been officially confirmed by the Ministry of Labour officials and it was not denied by the respondents

The court is simply amazed at this arrogance on the part of an employer who treated the Ministry of Labour official and all his efforts to end the strike with such contempt

The parties should realize that the labour officials perform their duties under the Trade Disputes Act which duties include settling and sorting out strikes and lockouts. They should be treated with respect and the court must warn the parties especially the employers like in the present case that such arrogant behaviour will not be tolerated

After careful consideration of the parties submissions and going through the investigation report of the Ministry of Labour the court finds itself in complete agreement with the ministry's finding and recommendation. The court finds that the grievants have suffered a wrongful dismissal

The court accordingly awards that the dismissal of all the grievants should be reduced to normal termination so that the grievants can be paid all their terminal benefits in accordance with the Collective Bargaining Agreement in force at the time

The court further awards the following compensation to the grievants for the wrongful loss of employment they have suffered

- (i) 10 months wages to all permanent employees who had worked for more than 10 years
- (ii) 6 months wages for those who had worked less than 10 years

'D 40 (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time.

It is emphasized that those notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
