Failure to give such notice will be taken into account in considering any application by an opponent for an order for costs if the opposition is uncontested by the applicant.

Where it is stated in the advertisement of the applicant that the mark, upon its registration, is to be limited to certain colours, the colours are, as far as possible, indicated in the accompanying representations of the mark in the usual heraldic manner.

- A person guilty of an election offence will be liable to the penalties imposed by the Election Offences Act (Cap. 66), and to the disqualifications imposed by the National Assembly and Presidential Elections Act.
