THE TRADE DISPUTES ACT

(Cap. 234)

COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 36 of the Trade Disputes Act, the Minister for Labour and Manpower Development, orders that every employer who employs not less than five (5) members of the Kenya Electrical Trades Allied Workers Union to—

- (a) deduct every month the sum of one hundred shillings in respect of trade union dues from the wages of each of his employees who is a member of that trade union;
- (b) pay ninety-five shillings (Sh. 95) of the total of the sums so deducted in any month, not later than the third day from the date on which such wages were paid, by crossed cheque made payable to the account of the Kenya Electrical Trades Allied Workers Union at the Standard Chartered Bank, Electricity House, Harambee Avenue, P.O. Box 30003, Nairobi;
- (c) pay five shillings (Sh. 5) of the total of the sums so deducted in any month, not later than the tenth day of the following month, by crossed cheque made payable to the account of the Central Organization of Trade Unions (Kenya) at Barclays Bank, Mama Ngina Street, P.O. Box 30011, Nairobi;
- (d) notify respectively, in writing, that trade union and that federation before the end of each month the total amount of all payments made to the account of that trade union and that federation, respectively, in that month; and
- (e) notify the Registrar of Trade Unions, in writing, before the end of each month the total amount of all payments made into the accounts of that union and that federation respectively in that month.

And in exercise of the powers conferred by section 36 (2) of the said Act, the orders notified by Gazette Notice No. 2601 of 1968, have been revoked.

THE GOVERNMENT LANDS ACT

(Cap. 280)

PLOTS FOR ALLOCATION—WEBUYE MUNICIPALITY

The Commissioner of Lands invites applications for the allocation of plots in the above municipality as described in the schedule hereto. A plan showing the plots may be obtained from the Public Map Office, P.O. Box 30089, Nairobi, on payment of KSh. 50, post free.

2. Completed applications should be submitted to the Commissioner of Lands, Nairobi, through the Town Clerk, Webuye. P.O. Box 586, Webuye, on prescribed forms which are available on payment of KSh. 100 non-refundable fee from the District Lands Office, Bungoma, and the office of the Town Clerk, P.O. Box 382, Bungoma.

3. Applications must be sent so as to reach the town clerk not later than noon, on, and the applicants must enclose with their applications either a banker's cheque, money order or postal order for KSh. 1,250, made payable to the Commissioner of Lands, as deposit which will be dealt as follows:

- (a) Credited to a successful applicant.
 - (b) Refunded to an unsuccessful applicant.
 - (c) Forfeited if a successful applicant fails to pay within thirty (30) days of the offer of a plot, and the applicant shall have no further claim thereto.
 - (d) KSh. 250 is non-refundable.
4. Each application should be accompanied by a statement indicating:
- (a) The amount of capital it is proposed to spend on the project.
 - (b) The amount of actual capital available for development with banker's letter or other evidence of financial status in support.
 - (c) The manner in which it is proposed to raise the balance required for development, if any.
 - (d) Full details of both residential and/or commercial properties owned by the applicant in town.
 - (e) Individual applicants to indicate numbers of their national identity cards.
 - (f) In case of companies, names of directors to be included.

5. The successful allottee of a plot shall pay to the Commissioner of Lands within thirty (30) days of notification that his/her application has been successful, the stand premium and proportion of the annual rent together with conveyancing fees, stamp duty, registration fees, contribution in lieu of rates, roads and drains charges and survey fees. In default of payment within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no claim to the plot.

General Conditions

The grant will be made under the provisions of the Trust Land Act, and title will be issued under the Registration of Titles Act (Cap. 281), or the Registered Land Act (Cap. 300), as the case may be.

2. The grant will be issued in the name of the allottee as given in the letter of allotment and will be subject to special conditions set out below.

3. The term of the grant will be for ninety-nine (99) years from the first day of the month following the issue of the letter of allotment.

Special Conditions

No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the local authority. The local authority shall not give its approval unless it is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall, within six (6) calendar months of the actual registration of the grant, submit in triplicate to the local authority plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewerage surface and sullage water) drawings, elevation and specifications of the buildings the grantee proposes to erect on the land and shall, within twenty-four (24) months of the said actual registration of the grant, complete the erection of such buildings and construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the local authority:

Provided that notwithstanding anything to the contrary contained in or implied by the Trust Land Act (Cap. 288), if default shall be made in performance or observance of any of the requirements of this condition it shall be lawful for the local authority or any person authorized by the local authority to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the local authority in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the local authority that he/she/they is/are unable to complete the buildings within the period aforesaid the local authority shall (at the grantee's expense) accept a surrender of land comprised herein:

Provided further that if such notice as aforesaid shall be given—

- (a) within twelve (12) months of the actual registration of the grant, the local authority shall refund to the grantee fifty (50) per cent of the stand premium paid in respect of the land; or
- (b) at any subsequent time prior to the expiration of the said building period, the local authority shall refund the grantee twenty-five (25) per centum of the said stand premium and in the event of notice being given after the expiration of the said building period, no refund shall be made.

5. The land and buildings shall only be used for shops, offices and flats (excluding sale of petrol or motor oils).

6. The buildings shall not cover more than fifty (50) per cent of area of the land or lesser area as may be laid down by the local authority in its by-laws.

7. The land shall not be used for the purposes of any trade business which the local authority considers to be dangerous or offensive.

8. The grantee shall not subdivide the land without the prior consent in writing of the council and Commissioner of Lands.

9. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof or any buildings therein except with prior consent in writing of the council and Commissioner of Lands. No application for such consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed.

10. The grantee shall pay to the local authority such sum as the local authority may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost, either pay (within seven (7) days of demand) or be refunded the amount by which the actual proportionate cost either exceeds or falls short of the amount paid as aforesaid.

11. The grantee shall from time to time pay to the local authority on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the local authority may assess.

12. Should the local authority at any time require the said roads to be constructed to a higher standard the grantee shall pay the local authority on demand such proportion of the cost of such construction as the local authority may assess.

13. The grantee shall pay such rates, taxes, charges, duties, assessments or out-goings of whatever description as may be imposed, charged or assessed by any government or local authority in lieu thereof.

14. The local authority or such person or authority as may be appointed for the purposes shall have the right to enter upon the land and lay and have access to water mains of all descriptions whether overhead or underground or interfere with any existing alignments of mains or service pipes or telephone or telegraph wires and electric mains.

15. The local authority reserves the right to revise the annual ground rental payable hereunder at the expiry of the 33rd and 66th year of the term hereby granted. Such rent will be at the rate of four (4) per cent of the unimproved freehold value of the land as assessed by the Commissioner of Lands on behalf of the local authority.

ISSUANCE OF LETTER OF INTERIM AUTHORITY

PURSUANT to the provisions of rule 9 (1) (3) of the Universities (Establishment of Universities) (Standardization, Accreditation and Supervision) Rules, 1989, it is notified for public information that the commission for higher education has approved the establishment of the Kenya Methodist University as a private university in Kenya. Accordingly, the institution has been issued with a letter of interim authority as is stipulated in rule 9 (2) of the said universities rules.

Academic Character:

Initially, the university will be offering undergraduate programmes in two phases. Phase I will cover theology with majors in divinity or theology; business administration and agriculture. Phase II will cover science and technology; home economics and health sciences. As part of these programmes, all undergraduate students will be required to take general studies aimed at providing broad educational background. In addition, the university will be involved in research and postgraduate training as an integral part of academic life. At a later stage, it will establish research institutes such as the institute of arid and semi-arid lands research. Such institutes will support teaching in various degree programmes. The university will also establish training institutes aimed at providing links between the academia and the people in the field through offering courses ranging from basic to advanced courses to cater for all sectors of the society.
