*Principal Lecturer (Research Methods) (K.I.A.) (One Post) (No. 308/97)*

*Salary scale.—K£7,872 to 10,803 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Applicants must have served in the grade of senior lecturer (job group "M") or an equivalent position for at least three (3) years. They must have a master's degree specializing in research in the areas of economics, management, sociology, physiology, demography or any other relevant field. In addition, they should have carried actual research and/or held responsibilities of team leading in research activities and have demonstrated proficiency in conducting senior level seminars.

*Duties and responsibilities:*

Successful candidates will be required to design courses, provide lectures and co-ordinate research activities in the institute; undertake quantitative and action research on either aspects of management of economics or social development and offer research consultancy services to clients.

*Senior Lecturer (Accounting and Finance) (K.I.A.) (Two Posts) (No. 309/97)*

*Salary scale.—K£6,918 to 9,837 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Applicants must be in possession of a master's degree specializing in finance or are C.P.A. (K) finalists or its equivalent and have undergone a training of trainers course. They must have also served as a lecturer I (job group L) or comparable position for a minimum period of three (3) years. Evidence of publication, participation in research and/or consultancy project will be an added advantage.

*Duties and responsibilities:*

Successful candidate will be required to design and conduct courses in finance and accounting, teach students preparing for C.P.A. final and carry out research and offer consultancy in one's area of specialization.

*Senior Lecturer (Training of Trainers) (K.I.A) (One Post) (No. 310/97)*

*Salary scale.—K£6,918 to 9,837 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Applicants must have served satisfactorily in the grade of lecturer I (job group "L") or equivalent position for at least three (3) years and be in possession of a bachelor's degree in education, a recognized trainers qualification such as diploma in education or training of trainers certificate and have demonstrated exceptional ability in training duties and/or research.

*Duties and responsibilities:*

Successful candidate will be expected to design training of trainers programmes, conduct training of trainers courses and advise the institute's staff on appropriate training techniques; help client organizations; conduct high-level seminars/workshops or symposia; and co-ordinate courses/or programmes.

*Chief Superintendent (Mechanical) (One Post) (No. 311/97)*

*Salary scale.—K£6,918 to 9,837 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Applicants must have served satisfactorily for at least three (3) years in the grade of senior superintendent (mechanical), job group "L" and shown professional competence and skills as reflected in work performance and results.

*Duties and responsibilities:*

Successful candidate will be responsible to the certifying officer/principal superintendent mechanical on all matters related to vehicle inspection in vehicle inspection centres, management of mechanical services, their operations, training and testing of vehicles and maintenance. The officer must also be conversant with finance, personnel, stores management and tendering.

*Fingerprint Officer I (Three Posts) (No. 312/97)*

*Salary scale.—K£4,827 to 7,140 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Candidates must be fingerprint officer II and must have served in the grade for at least three (3) years. They must have shown merit and ability in work performance. Must have good knowledge of chapters 107, 173 and 84 of the Laws of Kenya including court procedures and in the case of university graduates, are in possession of the fingerprint certificate "C".

*Duties and responsibilities:*

Duties include verification and certification of illegal and double registration of persons and certificates of previous convictions, as well as verification of fingerprint documents for issue and renewal of national identity cards. The officers may in addition be required to give expert fingerprint evidence in a court of law and assist the senior fingerprint officer in supervision and operations of medium sized section of the fingerprint bureau.

*Vacancies in the Ministry of Commerce and Industry:*

*Assistant Director of Weights and Measures (One Post) (No. 313/97)*

*Salary scale.—K£7,872 to 10,803 p.a. PENSIONABLE or AGREEMENT.*

*Requirements for appointment:*

Applicants must have served in the grade of chief weights and measures officer for a minimum period of three (3) years, be full member of the Institute of Trade Standards Administration (Kenya) and have demonstrated a high degree of professional competence and administrative ability to discharge responsibilities at this level.

*Duties and responsibilities:*

Duties and responsibilities at this level include heading any one of the three (3) divisions namely: field services, enforcement services and technical services. In the field services he will co-ordinate the field services of provincial, district or zonal offices. The officer will be responsible to the Director of Weights

and Measures for proper co-ordination of work programmes, setting targets for achievement and preparation of annual reports, monitoring of the field services vote book, preparation of estimates and overseeing staff training and development.

In the enforcement services division, the officer will be responsible to the Director of Weights and Measures for initiating and drafting amendments to the Weights and Measures Act; the Trade Description Act and the rules made under them; and investigating into offences arising from infringement of the Acts.

In the technical services division the officer will be responsible to the Director of Weights and Measures for the evaluation of new patterns of weighing or measuring equipment for the purposes of approval, acquisition, care and maintenance standards of weights and measures and testing equipment; and licensing of repairers and mechanics.

*Chief Weights and Measures Officer (Two Posts) (No. 314/97)*

*Salary scale.*—K£6,918 to 9,837 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must have served satisfactorily in the grade of senior weights and measures officer for at least three (3) years and be a full member of the Institute of Trade Standards Administration (Kenya).

*Duties and responsibilities:*

Duties and responsibilities will involve enforcement, technical training or administration and supervision of weights and measures personnel at the provincial level. Specifically, this may include seeing that bi-annual verification of operating standards and testing equipment is carried out in accordance with the Weights and Measures Act; maintenance of the record of standards book, enforcement of all the legislation for which the department is responsible. At the headquarters the officer may be assigned work involving analysis and evaluation of statistical data collected by field officers regarding the performance of certain weights and measures instruments for approval and up-dating of the existing weights and measures rules. The duties will include co-ordination of the field services at the headquarters, the officer may also be assigned to be in-charge of the training including co-ordination of training programmes in the department.

*Senior Weights and Measures Officer (One Post) (No. 315/97)*

*Salary scale.*—K£5,694 to 8,127 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must have served satisfactorily in the grade of weights and measures officer I for a minimum period of three (3) years and be full member of the Institute of Trade Standards Administration (Kenya).

*Duties and responsibilities:*

Duties and responsibilities will include being responsible for the supervision of weights and measures services in large districts or a number of districts and will perform a variety of enforcement and technical duties. These duties include examination and testing newly approved patterns of weighing and measuring equipment for trade use, testing repaired weighing and measuring instruments submitted by licensed technicians; work planning and supervision of staff to meet set targets; and collection and accounting for revenue received as fees payable by traders for services rendered. The officer may also deputize for the chief weights and measures officer in a provincial office.

At the headquarters the senior weights and measures officer may be assigned work involving analysis and evaluation of statistical data and/or up-dating of weights and measures rules. Alternatively, a senior weights and measures officer may be deployed in the training division where he may head a section and also assist in research and development of new weighing and measuring technology.

*Senior Trade Development Officer (Twenty-seven Posts) (No. 316/97)*

*Salary scale.*—K£5,694 to 8,127 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must have served as trade development officer I for a minimum period of three (3) years and have shown wide knowledge, competence and administrative ability, in the provision of trade development services.

*Duties and responsibilities:*

Duties and responsibilities at this level are complex and varied in scope and require adequate knowledge of established policies and directives in the trade development sector and basically involve—

- heading a district or a section at the ministry headquarters and being responsible for its operations; acting as the departmental representative in the District Development Committee; deputizing for the head of division at the headquarters and assisting in planning, allocating work and co-ordinating the general activities of the division including research, area study and preparation of development papers;
- enforcing the Trade Licensing Act by virtue of being a licensing officer and also directing dispersion of business activity and ensuring its orderly growth;
- establishing targets for markets and writing papers on export/import policy, tariffs, etc. in conjunction with Kenya Missions Abroad;
- providing technical assistance to export oriented, manufacturing entities and enforcing legislation thereof;
- co-ordinating a wide range of programmes on overall training needs both at home and abroad and also disseminating information to businessmen;
- deployment as commercial attache, head of a mission or assisting economic counsellor for efficient provision of trade services by the mission; and
- monitoring distribution of merchandise in consultation with parastatals attached to the ministry to ensure fair trade practices.

*Vacancies in the Ministry of Agriculture, Livestock Development and Marketing:**Deputy Director of Agriculture (Two Posts) (No. 317/97)*

*Salary scale.*—K£8,937 to 11,469 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must have served in the grade of assistant director of agriculture for at least three (3) years. In addition, they must have demonstrated a high degree of professional competence and administrative capability in either running of division at the headquarters or heading a province.

*Duties and responsibilities:*

The successful candidates will be in charge of divisions at the headquarters such as crop development division, farm management, etc. They will be responsible to the director of agriculture for planning, direction, control and also for the implementation of the development programmes under their divisions. An officer at this level may also be deployed as a provincial director of agriculture in provinces with larger and more complex agricultural projects and services.

*Deputy Director of Veterinary Services (Two Posts) (No. 318/97)*

*Salary scale.*—K£8,937 to 11,469 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must have served in the grade of assistant director of veterinary services (job group "M") for a period of not less than

three (3) years. They must have demonstrated a high degree of professional competence and administrative ability.

*Duties and responsibilities:*

The successful candidates will be responsible to the director of veterinary services for planning, directing, controlling and co-ordinating all activities within their divisions and also for the implementation of veterinary development programmes under their divisions. They may be required to head specific divisions at the headquarters such as investigation laboratories and development of veterinary services or be in charge of complex provinces.

*Senior Laboratory Technologist (One Post) (No. 319/97)*

*Salary scale.*—K£4,827 to 7,140 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must be in possession of the higher national diploma and must have completed at least three (3) years' satisfactory service as laboratory technologist I and have shown considerable capabilities and efficiency in management of laboratory work. Those applicants without the higher national diploma but who have served for at least five (5) years in the grade of laboratory technologist I will also be considered.

*Duties and responsibilities:*

The successful candidate will be deployed in one of the regional veterinary investigation laboratories or at the Central Veterinary Investigation Laboratory, Kabete. His/her duties will include co-ordination of the provision of laboratory services as well as allocation of duties and distribution of staff in various units. In addition, the officer will be expected to do actual bench work in his/her area of specialization. He/she will also be required to train and supervise staff, ensure availability of laboratory supplies and proper maintenance of relevant equipment.

*Assistant Livestock Production Officer I (Two Posts) (No. 320/97)*

*Salary scale.*—K£4,092 to 6,066 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

For appointment to the grade of assistant livestock production officer I, an officer must—

- (a) have served at the level of assistant livestock production officer II for a minimum period of three (3) years; and
- (b) have shown merit and ability in work performance.

*Duties and responsibilities:*

The successful candidates will assist the district or divisional livestock production officers in extension services and livestock marketing. Officers in this grade may also be deployed as holding ground managers, managers or teachers/demonstrators in training institutions under the livestock production department.

*Vacancies in the Ministry of Environment and Natural Resources:**Assistant Chief Conservator of Forests (Three Posts) (No. 321/97)*

*Salary scale.*—K£7,872 to 10,803 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

Applicants must—

- (a) have served as senior conservator of forests for at least three (3) years;
- (b) have gained extensive experience and knowledge in forestry policy formulation and implementation, forestry management and development and proper utilization of forest produce and of forestry extension services; and
- (c) have demonstrated administrative capability in work performance.

*Duties and responsibilities:*

The successful candidates will be in charge of a province or head of a branch in division at the forest department's headquarters. An officer deployed in a province will be responsible to the chief conservator of forests at that level.

This includes the interpretation and implementation of the forestry policy in the province; forest management and conservation measures; reviewing and overseeing the preparation of forest management plans and adherence to them when approved; co-ordination of seedlings production and afforestation programmes in the province; being secretary to the forest licensing and review committee; co-ordinating tree planting week's activities in the province; overseeing the handling of financial matters estimates and revenue collection activities and maintenance of staff welfare and discipline.

*Assistant Director of Environment (Four Posts) (No. 322/97)*

*Salary scale.*—K£7,872 to 10,803 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

For appointment to the grade of assistant director of environment, an officer must—

- (a) have served as senior environment officer for at least three (3) years; and
- (b) have shown professional and administrative capability in work performance.

*Duties and responsibilities:*

Duties at this level include headship of one of the departmental programmes like resource management, environmental education and information, environmental monitoring and environmental law, etc; assisting the director in the co-ordination, harmonization, and supervision of the activities of ministries and other institutions dealing with environment; co-ordination of bilaterally and multilaterally funded projects and secretariat's participation in the provincial and district development committees and other relevant meetings and preparation of annual reports on the programme. Duties further involve the design and enforcement of environmental standards; the control of project budgets; and negotiation with external organizations/agencies for funds.

*Chief Chemist (One Post) (No. 323/97)*

*Salary scale.*—K£7,872 to 10,803 p.a. PENSIONABLE or AGREEMENT.

*Requirements for appointment:*

For appointment to the grade of chief chemist, candidates must have served as senior chemist for at least three (3) years, in addition, have M.Sc. degree in the relevant field and published at least a scientific paper in his field of specialization or research conducted under his direction. Apart from demonstration of high professional competence, candidates must possess administrative qualities attained through experience and attendance of appropriate level management course for senior Government officers. They must have good public relations to deal with various external resource persons and should have sufficient knowledge of all the functions relating to the job.

*Duties and responsibilities:*

Duties at this level require an expert in all aspects of professional services provided in the department for which successful candidate is responsible. The successful candidate will be responsible for planning, co-ordination, development and evaluation of research projects, direct research for publication and dissemination of scientific information on chemicals and related issues. He will be responsible for staff matters relating to their career development and general administration. In addition, the successful candidate will be expected to ensure availability of laboratory supplies and equipment as well as undertaking technical evaluation of quotations and tenders for laboratory stores and services.

*Environment Officer (Three Posts) (No. 324/97)*

**Salary scale.**—K£5,694 to 8,127 p.a. PENSIONABLE or AGREEMENT.

**Requirements for appointment:**

For appointment to this grade, applicants must—

- (a) have served in the grade of environment officer II for at least three (3) years; and
- (b) have demonstrated considerable competence in work performance.

**Duties and responsibilities:**

Duties and responsibilities at this level include carrying out environmental protection education activities at primary and secondary schools and at tertiary levels; liaison with Kenya Institute of Education (K.I.E.) and adult education department to incorporate environmental preservation and protection issues in the curriculum for schools and adult classes; and organization of world environmental day activities and other environmental celebrations in addition to participation in ministerial show committees at all levels.

The officer at this level will perform duties involving the study of environmental protection measures proposed by estate and industrial developers *vis-a-vis* the laid down regulations; study environmental impact reports and make the necessary recommendations, secretary to the inter-ministerial technical committee, co-ordination of matters related to International Union for Conservation of Nature (I.U.C.N.) and other relevant organizations and the implementation of measures to combat desertification, and evaluate, in consultation with wildlife conservation and management, the effectiveness of the shortages for the protection of endangered species; appraisal of rural resources management programme; dissemination of ecological research findings to relevant Government ministries, other institutions and organizations and the assessment of queries with a view to ascertaining their environmental impact.

*Environment Officer II (Six Posts) (No. 325/97)*

**Salary scale.**—K£4,827 to 7,140 p.a. PENSIONABLE or AGREEMENT.

**Requirements for appointment:****(a) Direct appointment:**

For direct appointment to this grade, a candidate must have a bachelor's degree in civil engineering, environmental science, biological sciences, physical science, forestry, agriculture, law, economics, statistics or urban planning.

**(b) Promotion:**

For promotion to this grade an officer must—

The number of outstanding complaints at the end of this period is one thousand five hundred and thirty (1,530).

The latest summary of disciplinary causes shows that in the 14 months from 3rd May, 1996, to 4th July, 1997 the Disciplinary Committee dealt with 37 causes comprising 63 charges. One charge was stood over indefinitely as the advocate has disappeared abroad. There were:

- 4 suspensions;
- 15 admonitions; and
- 22 were withdrawn or settled.

The fines totalled KSh. 172,000; and costs totalled KSh. 77,500.

In exactly the same period, this Commission filed no less than 150 complaints with the Disciplinary Committee, most of them containing more than one charge. It is clear that stiffer penalties and acceleration of the disciplinary process is overdue. There are by our count 364 causes pending before that Committee as at 29th July, 1997.
