NOTICE OF ELECTION OF MEMBERS OF PARLIAMENT

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 13 subsection (3) (b) of the National Assembly and Presidential Elections Act and Regulations 8(3) and 14 of the Presidential and Parliamentary Elections Regulations, the Electoral Commission gives notice that:

- a) An election is to be held of a member to serve in the National Assembly for each of the constituencies set out in the Schedule hereunder.
- b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before Sunday the 7th December, 1997.
- c) The day for nomination for the parliamentary election will be the 8th and 9th December 1997, and nomination papers may be delivered by candidates to the Returning Officer between the hours of eight o'clock in the morning and one o'clock in the afternoon and between the hours of two o'clock and four o'clock in the afternoon of the days.
- d) If the parliamentary election is contested the poll will take place on the 29th December, 1997.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.
