THE LOCAL GOVERNMENT ACT  
(Cap. 265)

## POWERS TO DIRECT PERFORMANCE OF DUTIES

IN EXERCISE of the powers conferred by section 246 (1) of the Local Government Act, the Minister for Local Government directs all local authorities to perform the functions and duties imposed on them by the Act and in particular to ensure that—

all buildings have appropriate and approved building plans; inspection of all building construction work is effectively undertaken;

all buildings have occupation certificates; statutory inspection of buildings is carried out regularly; ruinous and dangerous buildings are shored up, secured, repaired, renewed, removed, or otherwise made safe.

In the event that a local authority fails to comply with this notice, the minister may himself perform the duties in question, and shall be entitled to recover from the local authority the expenses incurred and to defray such expenses as may be deemed appropriate.
