JUDICIAL COMMISSION OF INQUIRY

Citation

A JUDICIAL COMMISSION to inquire into the circumstances surrounding and leading to a fire tragedy at Bombolulu Girls High School, on 25th March, 1998.

Now, therefore, in exercise of the powers conferred upon the President by section 3 of the Commissions of Inquiry Act, I, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, do direct the commissioners to hold an inquiry at Mombasa Law Courts with immediate effect. The terms of reference shall be—

- to inquire into the circumstances surrounding and leading to the fire tragedy which occurred at Bombolulu Girls High School, on the night of 25th–26th March, 1998;
- to inquire generally or in particular into any other matter pertaining to the above;
- to make such recommendations on the matter as may appear to the commission to be necessary and in particular such recommendations as will assist to prevent similar accidents in institutions of learning;

and in accordance with the provisions of section 7 (1) of the said Act, to report thereon as soon as reasonably practicable, but not later than 30th April, 1998.

And I do command all other persons whom it may concern to take due notice hereof and to give their obedience accordingly.
