(Cap. 504)

MERGER OF MESSRS. PRICE WATERHOUSE OF P.O. BOX 41968, NAIROBI AND MESSRS. COOPERS AND LYBRAND OF P.O. BOX 30158, NAIROBI

IN EXERCISE of the powers conferred by section 31 (3) of the Restrictive Trade Practices, Monopolies and Price Control Act, the Minister for Finance has authorized the merger of Messrs. Price Waterhouse and Coopers and Lybrand subject to the following conditions:

- (a) Pursuant to the provisions of section 30 (c) of the Restrictive Trade Practices, Monopolies and Price Control Act, Cap. 504 of the laws of Kenya, the merger shall not be disadvantageous to the creation and maintenance of Kenya's employment opportunities to the extent that it may encourage capital intensive technology in lieu of labour intensive technology.
- (b) That the new partnership, PricewaterhouseCoopers, shall at all times restrain itself from the abuse of dominance in the market place so as to safeguard the competitiveness of Kenya's professional services sector.
- (c) That the new partnership shall strictly adhere, uphold and maintain the professional code of ethics in the professional services sector of the economy.
- (d) That the new partnership shall not increase unreasonably the cost of its services to the economy.
