The terms of reference of the Task Force are—

- to consider the challenges posed by HIV/AIDS to all laws with a view to making appropriate recommendations for the reform of our laws with a view to better prevention, management and control of the HIV/AIDS disaster in Kenya;
- to advise on the adoption of guidelines, rules, regulations and procedures immediately required to address the HIV/AIDS disaster;
- to look into the human rights issues affecting widows and widowers, orphans, employees and other workers and people living with HIV/AIDS among others and make recommendations thereon;

- (d) to address legal matters concerning HIV/AIDS and related to marriage, research, insurance and drug access matters and make recommendations thereon;
- (e) to review offences under the Penal Code and other offences in the laws of Kenya in the light of the HIV/AIDS pandemic and make recommendations on how the penal laws can be strengthened;
- (f) to make such other recommendations that are incidental to foregoing.

The Task Force shall have the power with the approval of the Attorney-General to co-opt members or appoint committees as it deems fit only for specialized aspects of its terms of reference. The Task Force shall submit its report to the Attorney-General not later than 31st December, 2001.

DECISION OF THE ELECTRICITY REGULATORY BOARD ON THE APPLICATION BY PAN AFRICAN PAPER MILLS (E.A.)

LIMITED FOR REVIEW OF THE BOARD'S DECISION DATED MAY 25TH 2000 IN THE MATTER BETWEEN PAN AFRICAN PAPER

MILLS (E.A.) LIMITED AND THE KENYA POWER AND LIGHTING COMPANY LIMITED

*Background:*

On March 16th 1999, Pan African Paper Mills (E.A.) Limited (P.P.M.) made an application to the Electricity Regulatory Board (the Board) requesting that the Board order, *inter alia*, a substantial reduction in the unit cost of electricity supplied by the Kenya Power and Lighting Company Limited (K.P.L.C.) to P.P.M from KSh. 4.20 per KWhr. to KSh. 1.4 per KWhr. P.P.M. argued that this reduction was necessary to enable it compete in the local and international paper markets.

K.P.L.C., at the invitation of the Board, responded to the application by P.P.M. and the Board thereafter directed that the two parties enter into negotiations with a view to agreeing on the rates to be charged and report back to the Board for endorsement. The two parties held several meetings between July 15th 1999 and October 28th 1999 after which K.P.L.C. made an offer to P.P.M. K.P.L.C.'s offer was not acceptable to P.P.M. The matter was then referred back to the Board.

On May 25th 2000, the Board delivered the following decision:

- (a) That P.P.M. qualifies to negotiate with K.P.L.C. for a large retail contract for supply of electrical energy under the Electric Power Act;
- (b) That P.P.M. is not entitled to any compensation from K.P.L.C. by way of tariff rebate on account of P.P.M.'s financial contribution to the construction of the 132 KV. service line;
- (c) That P.P.M. be removed from Category C3 band of consumers and placed under a new Category C5 for large commercial and industrial consumers whose consumption is in excess of 7,500,000 KWhr. per month;
- (d) That the following electricity tariffs and charges be levied by K.P.L.C. for Category C5 consumers—
  - (i) Fixed charge                      KSh. 7,500 per month.
  - (ii) Unit rate                              KSh. 4.00 per KWhr.
  - (iii) Demand charge                      KSh. 80 per KVA.

- (e) That the new rates and tariffs take effect from the date of the Board's decision.

On January 31st 2001, P.P.M. lodged an application with the Board requesting, *inter alia*, that the Board reviews its decision of May 25, 2000. P.P.M. stated that its application for review was supported by new evidence, which they were not able to present to the Board at the original hearing.

*P.P.M.'s Application for Review:*

P.P.M. in their application for review dated January 31st 2001 averred that following the lifting of the two-tier tariff system in July 2000 as a consequence of the intensified power rationing, the new tariffs became discriminatory and unjust to Category C5 consumers.

It will be recalled that the two-tier tariff system instituted by the Board on August 1, 1999 enabled industrial consumers to consume power at reduced rates during off-peak thereby making substantial savings on their energy bills and improving the load factor in the nation grid.

The main issues and grounds for review advanced by P.P.M. are as follows—

*(a) Demand Charge:*

P.P.M. has requested the Board to review its earlier decision and reduce the existing demand charge rate for Category C5 consumers to KSh.50 per peak down from the current KSh. 80 per KVA peak per month. The demand charge in the tariff structure is intended to recover the annuitized capital cost for transmission and distribution network and fixed operation and maintenance network costs.

P.P.M. argues that the Long Run Marginal Cost (LRMC) allocates network demand costs to each consumer category in proportion to the burden they impose on the supply system which is determined by the level of supply voltage and quantity of electricity consumed. The present tariff structure recognizes HV, MV and LV connected large consumers and assigns them to category C3, C2 and C1 respectively. In the current tariff, HV connected consumers are sub-divided into three categories of C3, C4 and C5. The network demand costs are allocated in the following ratios:

$$C1:C2:C3=5.3:2.9:1$$

The present tariff rates of KSh. 300, 200 and 100 for category C1, C2 and C3 respectively reflect a ratio of 3:2:1 on the current demand charges. These rates, in P.P.M.'s view, are discriminatory against C3 consumers and should be amended to reflect the LRMC derived ratio of 5.3:2.9:1 given above.

Using the LRMC derived ratio and assuming KPLC's total revenue remain the same, P.P.M. argues that the ratio of MVA demand to large consumers should therefore be KSh. 330 per KVA (rounded from KSh. 334), KSh. 180 per KVA. (rounded from KSh. 176) and KSh. 60 per KVA (rounded from KSh. 63) for categories C1, C2 and C3 respectively. Consequently, in PPM's view, category C4 and C5 consumers should be charged KSh. 50 per KVA (rounded from KSh. 48).

*(b) Unit Charge:*

PPM has requested the Board to review its earlier decision and reduce the percentage of technical losses built in the tariff for Category C5 consumers from the current 15% to 10% thereby translating into a reduction of 7% of the nominal tariff rate to KSh.2.00 per KWhr. PPM argues that the relative burden placed by consumers and the supply system depends on their supply voltage, quantity and nature of the loads and consumption pattern. The lower the burden, the lower the unit charges should be for each category of consumers.

P.P.M. avers that recent LRMC analysis for the Kenyan electricity supply system gives the following facts:

Financially adjusted LRMC for system	US Cents 9.1
A strict LRMC for system	US Cents 8.1
Financially adjusted LRMC for category C3	US Cents 5.8

An average strict LRMC for category C3	US Cents 5.4
A strict LRMC for standard hours for C3	US Cents 5.2

The ratio of category C3 base tariff rate (without peak hour and financial adjustments) to the financially adjusted yield of the supply system is given, based on this LRMC analysis, as:

$$5.2:9.1 \text{ or } 57.1$$



The KPLC average yield for the year 1999/2000 is given as KSh.7.00 per KWhr. PPM contends that if the effect of fuel oil recoveries is removed from this figure it becomes KSh.4.95 per KWhr. They argue that since fuel oil adjustments are not considered in derivation of the nominal LRMC, removal of its distortion on the average yield is justified, before the annual yield figure is applied in further analysis.

Based on the ideal LRMC ratio of 1:0.57, the ideal nominal charge for category C3 tariff becomes Kshs.2.30 based on a system average of Kshs.4.95. This figure is adjusted using the present ratio of 4.17:4.07:4.00 for tariff categories C3n: C4: C5 given in the current tariff rates to yield the following new rates:

C3	:	KSh. 2.30 per KWhr.
C4	:	KSh. 2.25 per KWhr.
C5	:	KSh. 2.20 per KWhr.

*(c) Fuel Oil Cost Adjustment (FOCA):*

PPM has requested the board to review its earlier decision by reducing the L factor from 15% to 10% in calculation of the FOCA.

The formula used to account for fluctuation in fuel oil prices includes a component on losses L, set at 15%. The total losses in the supply system are made up of three components,  $L=L1+L2+L3$ :

- (i) L1—Technical losses in the generation system
- (ii) L2—Technical losses in the network; and
- (iii) L3—System non-technical losses

The current schedule of tariff rates defines L as losses in the transmission and distribution network, which is equal to L2 given above. Recent analysis of the Kenyan system gives the following values: L1 = 1.7%, L2 = 9.8% and L3 = 10%. There is no justification to load category C5 consumers with non-technical losses (L3) to which they do not contribute.

*(d) Foreign Exchange Rate Fluctuation Adjustment (FERFA):*

PPM has requested the Board to review its earlier decision by reducing the L factor from 15% to 10% in calculation of FERFA.

*The Board's Decision:*

The Board noted that the report alluded to by PPM in their application for review was the Tariff Study Report (1998) by Merz McLellan which was used to establish the current tariffs and allocate losses (generation, transmission and distribution) depending on the supply voltage. Any review of retail tariffs would therefore entail correct application of LRMC methods to the entire customer base and certainly not by addressing individual customer categories. The current KVA demand charge does not discriminate against C5 consumers but rather is derived from appropriate allocation of losses as recommended by the Tariff Study Report. The losses in the system in real terms are 21% but a lower L factor of 15% is used in the tariff system as an incentive to KPLC to reduce the losses.

The Board is further of the view that P.P.M.'s analysis based on the 1999/2000 tariff yield of KSh. 7.00/KWhr. is a function of abnormal circumstances resulting from load shedding. A more accurate starting point for any analysis would be reference to the average yield anticipated under the approved tariffs and the underlying assumptions.

In its application for a review, P.P.M. requested the Board to review the tariff charges in category C5 as follows—

- Reduce the demand charge from KSh. 80.00 to 50.00 per kVA per month.
- Reduce the unit charge from KSh. 4.00 to 2.00 per kWhr.
- Reduce fuel oil cost adjustment (FOCA) and foreign exchange rate fluctuation adjustment (FERFA) charges by 7%.

The Board has performed an analysis of the impact of reducing demand and energy charges as per P.P.M.'s request. The analysis has ascertained the magnitude of change in the target tariff yield, as well as the demand and energy charges for customers in categories B1 – C4 engendered by reducing the demand and energy charges for category C5. The objective was to vary the energy and demand charges for customers in categories B1 – C4 in such a way as to achieve the average tariff yield of 629 cts/kWh. while maintaining P.P.M. energy and demand charges at the requested values.

P.P.M. requested for a reduction of Electricity Tariffs citing enormous increases in the share of electricity to the total production cost from 8.5% in 1993 to 24.5% in 1998. PPM claimed that "contributions from other inputs have practically stayed the same or increased only marginally". The Board sought clarifications from PPM regarding the expenses making up the cost of power and fuel as presented in audited profit and loss accounts of the company

P.P.M. obliged and gave the components as: (1) Cost of electricity purchased from K.P.L.C., (2) Cost of fuel oil for co-generation and (3) Cost of fuel oil used to generate steam. P.P.M. attributes electricity expenses to cost of electricity purchased from K.P.L.C. and cost of fuel oil for co-generation. The Board also obtained the cost of electricity billed to PPM directly from K.P.L.C. for comparison purposes. The cost of electricity from the two sources tallied.

*It is the view of the Board that:*

The increase in electricity cost to PPM reflects the pattern of increases in tariff levels in the country whose aim is to align the tariffs to the long-run marginal costs. It increased by 62% between 1997 and 1998 and by 11% between 1999 and 2000. The cost of electricity increased from KSh. 619m in 1998 to KSh. 706m in 2000. These increases are marginal compared with increases on other company expenses as discussed here below.

The cost of electricity as a percentage of total production cost has consistently been below the 24.5% quoted by P.P.M. Indeed the highest electricity has contributed, as a percentage of total production cost is 21%, which occurred in 1998 and 1999. It is also instructive that in 2000, electricity accounted for 18% of P.P.M.'s total production costs.

It is inappropriate to combine cost of fuel oil used for co-generation and cost of purchased electricity from K.P.L.C. Instead, the cost of fuel oil used for co-generation should be treated separately as the electricity generated is a by-product of paper production.

In 2000, the cost of fuel oil used to generate steam accounted for 28% while 20% of total production costs was attributed to raw materials. In absolute terms, these two cost centres accounted for KSh. 1.9b (~ 48%) of P.P.M.'s total production costs in year ended June, 2000. It is therefore, evident that in terms of impact on the production costs, the cost of raw materials and fuel oil are more significant than electricity. It should also be noted that whereas year 2000 electricity costs increased by 11.5% over the 1999 figure, the corresponding increases for raw materials and fuel oil costs were 32% and 85% respectively.

Interest expense and stores, chemicals and spares are other significant costs, which have adversely affected the profitability and liquidity of PPM in the year ended June, 2000, the interest expense accounted for 9% of the total company costs, while stores, chemicals & spares accounted for 8%.

If the Board were to grant the request made by P.P.M., K.P.L.C. will lose KSh. 302 Million per annum if the base tariff is reduced from the current KSh. 4 to KSh. 2 per kWh. and a further KSh. 10 Million per annum if KVA demand charge is reduced from KSh. 80 to KSh. 50. The total revenue loss to K.P.L.C. will be KSh. 312 million per annum, if the request by P.P.M. is granted.

It is noteworthy that the request for an annual rebate of KSh. 312 million is not sufficient to offset the burden of P.P.M.'s expenses if its other cost centres are not addressed.

The Board sought information from eight C3 electricity customers regarding the percentage of electricity cost to their total production costs. Five of the eight companies responded positively and provided the data shown in Table 2 below. It is clear from the Table that some companies incurred more than 20% of electricity cost as a percentage of total production cost whereas some incurred less than 12% of total production cost in 2000. When the three representative years are considered, P.P.M. spends about average on electricity cost. If P.P.M.'s request is accepted, then it will be imperative to give similar concessions to other large power consumers to avoid charges of discrimination and unfair treatment.

From the above analysis, it is clear that the impact of electricity cost to the company is of less significance to the production costs compared to other cost centers and in particular, costs of fuel oil and raw materials.

Other large power consumers spent much more on electricity as a proportion of their total production cost.

Finally, in view of the foregoing, the Board declines to grant any of the requests made by PPM in their application for review.
