Terms of reference:

The terms of reference of the committee are-

- (a) to oversee the implementation of the strategy and action plan of the Environmental Management and Co-ordination Act with special emphasis on the establishment of institutions, committees, tribunals, registries, etc. proposed under the Environmental Management and Co-ordination Act;
- (b) to facilitate the drafting, review and adoption of guidelines, rules, regulations and procedures required under the Environmental Management and Co-ordination Act;

- (c) to make recommendations to guide national response to Multilateral Environmental Agreements (MEAs), treaties, conventions including financial mechanism such as GEF and the multilateral Ozone Fund and other emerging financing mechanisms in order to maximize the national benefits arising from participating thereto;
- (d) to streamline and co-ordinate national preparations for the World Summit on Sustainable Development, (RIO + 10
- (e) to provide transitional logistic and other support for the proper functioning of the National Environment Council, the Standards and Enforcement Review Committee, Public Complaints Committee and the Provincial and District Environment Committees among others; and
- (f) to effectively publicize the Environmental Management and Co-ordination Act.

Powers of the committee:

In the execution of its terms of reference, the committee shall have the power to-

- (a) regulate its own procedure;
- (b) determine its method of work;
- (c) appoint such sub-committees as may from time to time, be necessary for the furtherance of its terms of reference;
- (d) engage the services of such consultants or experts as may be necessary for the execution of its terms of reference in such terms and conditions as the committee shall deem appropriate:
- (e) do or perform such other things or acts as are necessary or expedient for the execution of its terms of reference.

Secretariat:

The secretariat shall be based at the headquarters of the Ministry of Environment and Natural Resources, Maji House, Ngong Road, P.O. Box 30521, Nairobi.

Reporting and duration:

The committee shall execute its terms of reference with all due diligence and speed and shall submit to the Minister-

- (a) monthly reports of its progress; and
- (b) a final report, not later than 31st December, 2002.





IMPORTANT NOTICE TO SUBSCRIBERS TO THE "KENYA GAZETTE"

THE following notes are for the guidance of persons submitting "copy" for inclusion in the Kenya Gazette, Supplement, etc.:

- The Kenya Gazette contains notices of a general nature which do not affect legislation. They are, therefore submitted to the Government Printer directly.
- (2) Legislative Supplement contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—
Kenya Gazette

- "D 40. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) Ministries will be required to pay for the Kenya Gazette and to meet the cost of advertising in it.
- (3) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
