COLLECTION OF TRADE UNION DUES

IN EXERCISE of the powers conferred by section 45 of the Trade Disputes Act, the Minister for Labour—

Terms of reference:

The terms of reference of the Committee are-

- (a) to co-ordinate and monitor implementation of International Humanitarian Law in Kenya;
- (b) to advise the Government on International Humanitarian Law instruments that need to be ratified;
- (c) to review the existing legislation and recommend amendments where necessary;
- (d) to recommend new legislation where applicable;
- (e) to advise and assist on reporting obligations;
- (f) to advise on administrative measures required;
- (g) to co-ordinate, monitor and evaluate dissemination; and
- (h) to undertake or commission research on development in International Humanitarian Law and make appropriate recommendations to the Government.

#### Powers of the Committee:

In the execution of its terms of reference the Committee shall with the approval of the Attorney-General, have the power to-

- (a) co-opt members or appoint nominees as it deems fit only for specialized aspects of its terms of reference;
- (b) source additional funding for its activities; and
- (c) do or perform such other things or acts as are necessary or expedient for the execution of its terms of reference.

Reporting and duration:

The Committee shall execute its terms of reference with all due diligence and speed and shall submit to the Attorney-General its annual report not later than 31st December, 2002.

The secretariat of the Committee shall be based at the Attorney-General's Chambers, 2nd Floor, Room No. 207. # IMPORTANT NOTICE TO SUBSCRIBERS TO THE "KENYA GAZETTE"

THE following notes are for the guidance of persons submitting "copy" for inclusion in the Kenya Gazette, Supplement, etc.:

- (1) The Kenya Gazette contains notices of a general nature which do not affect legislation. They are, therefore submitted to the Government Printer directly.
- (2) Legislative Supplement contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

- "D 40. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) Ministries will be required to pay for the Kenyu Guzette and to meet the cost of advertising in it.
- (3) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
