Terms of Reference:

The terms of reference of the Committee are—

- (a) to facilitate the implementation of the strategy and action plan of the Environmental Management and Co-ordination Act, with special emphasis on the establishment of institutions, committees, tribunals, registries, etc. proposed under the Environmental Management and Co-ordination Act;
- (b) to facilitate the drafting, review and adoption of guidelines, rules, regulations and procedures required under the Environmental Management and Co-ordination Act;
- (c) to provide transitional logistic and other support for the proper functioning of the National Environment Council, the Standards and Enforcement Review Committee, Public Complaints Committee and the Provincial and District Environment Committees amongst others; and
- (d) to effectively publicize the Environmental Management and Co-ordination Act.

Powers of the Committee:

In the execution of its terms of reference, the Committee shall have the power to—

- (a) regulate its own procedure;
- (b) determine its method of work;
- (c) within its budgetary provisions as approved by the Minister—
 - (i) appoint such sub-committees as may from time to time be necessary for the furtherance of its terms of reference;
 - (ii) engage the services of such consultants or experts as may be necessary for the execution of its terms of reference is such terms and conditions as the committee shall deem appropriate; and

- (d) do or perform such other things or acts as the necessary or expedient for the execution of its terms of reference.

The Secretariat shall be based at the Headquarters of the Ministry of Environment and Natural Resources, Maji House, Ngong Road, P.O. Box 30521, Nairobi.

Reporting and Duration:

The Committee shall execute its terms of reference with all due diligence and speed and shall submit to the Minister—

- (a) monthly reports of its progress; and
- (b) a final report, not later than 31st December, 2002.

The terms of reference of the Task Force are—

- (a) to examine and review all the maritime laws including the Maritime Zones Act (Cap. 371); The Merchant Shipping Act (Cap. 389); The Maritime Insurance Act (Cap. 390); The Carriage of Goods by Sea Act (Cap. 392); The Water Act (Cap. 372); The Lakes and Rivers Act (Cap. 409); The Ferries Act (Cap. 410) and make recommendations for appropriate legislation to replace or amend any or of the maritime law statutes;
- (b) to examine and review the relevant maritime pollution prevention conventions and existing environmental legislation with a view to establishing a co-ordinated and comprehensive marine pollution regulatory regime;
- (c) to examine and review the current legislative framework governing the admiralty jurisdiction of the Kenya High Courts in respect of matters arising on the high seas or in territorial waters in Kenya with a view to safeguarding Kenya's international interests;
- (d) to make recommendations on proposals for reform or amendment of maritime laws to ensure that they are consistent with the conventions and recommendations of the International Maritime Organization and other treaty instruments as well as international protocols to which Kenya is a party and where appropriate make recommendations on how the process of implementation of such treaties, conventions or protocols can be improved or enhanced;
- (e) to examine the possibility of establishing a department of maritime law at one of the local universities to stimulate interest among lawyers on maritime related issues as well as to teach and carry out advanced research in order to extend and stimulate expertise in maritime affairs;
- (f) to examine the possibility of establishing a Maritime Regulatory Authority that would oversee maritime trade and regulate merchant shipping practise in Kenya in order to realise the full potential of the maritime industry in Kenya;
- (g) to assess and recommend on all legislative, administrative and policy matters pertaining to the security, protection, safety, passage and exploitation of the territorial waters including the Exclusive Economic Zones; and
- (h) to make recommendations on such other matters related to or incidental to the foregoing.

The Task Force will have the power, with the approval of the Attorney-General, to co-opt members or appoint committees as it deems fit only for specialized aspects of its terms of reference. The Task Force shall submit interim reports to the Attorney-General after every two (2) months and the final report not later than 31st October, 2002.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
