In law, this is the only time a person can identify unqualified imposters in their constituencies or the underage who may have succeeded to cheat the registration staff and so on and be able to seek a legal remedy. The public should remember that people were able to apply to register in a constituency or transfer without setting their feet on that constituency. Hence the residents of any given constituency did not have the opportunity to physically see some of these applicants. Looking at the revised registers they will be able to weed out pretenders. Thus the right and the opportunity to inspect the revised register is so crucial this time that it should be taken with the seriousness it deserves. Those wishing to inspect whether he/she was registered or transferred can send a representative if he/she is not able

The Electoral Commission also appeals to registered political parties to afford the time, money and personnel to carry out inspection of these registers for their own sake and that of their members.

The registration officials will be all too happy to advise any person on any matter he/she may wish to be clarified and on the right procedures.

**IMPORTANT NOTICE TO SUBSCRIBERS

- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

*Kenya Gazette*

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
