IT IS notified for general information that pursuant to section 58 of the Environmental Management and Co-ordination Act, an Environmental Impact Assessment Study Report for the proposed Eldoret Sanitation Project whose background is set out in the schedule hereto has been prepared and is ready for inspection at the centres indicated in the schedule.

## SCHEDULE

*Background:*

The Government of Kenya through the Ministry of Local Government has received funds on behalf of the Municipal Council of Eldoret for the Eldoret Sanitation Project from KfW, a German governmental financing organization.

The objective of the Eldoret Sanitation Project is to augment and extend the present sewerage system in order to provide the town with adequate sanitation and sewerage system. The sanitation and sewerage improvements will improve the sanitary and environmental conditions within Eldoret Municipality and will also protect the surface water resources of the Sosiani River which is being used downstream for water supply purposes. The improved sanitary and environmental conditions will further enhance both the living standards of the local population and the town's economic development.

The environmental impact assessment study report for the project has been prepared and can be inspected at the following centres—

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

*Kenya Gazette*

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
