NOTIFICATION

IT IS notified for general information that the Government of Kenya through the Ministry of Transport and Communications, acting through the Merchant Shipping Superintendent's Office and the Democratic Republic of Congo through the Ministry of Transport and Communications acting through the "Office de Gestion du Fret Maritime" (Office for the Maritime Freight Management hereinafter referred to as "OGEFREM") signed an agreement known as "Maritime Freight Management Agreement" (hereinafter referred to as "Agreement") on the 30th May, 2000. The Agreement came into effect on the 1st July, 2000 and pursuant to the provisions of the said Agreement and the provisions of section 313 of the Act, the Merchant Shipping Superintendent shall—

- (a) collect, on behalf of OGEFREM, a levy of one point eight per cent (1.8%), through the Kenya Ports Authority, of the gross freight charges on all import cargo passing through the Port of Mombasa destined to the Democratic Republic of Congo.
- (b) ensure that all payments made under paragraph (a) are in US dollars;
- (c) demand production of the following documents by the shipping lines or their agents in order to facilitate collection of the one point eight per cent (1.8%) levy referred to in paragraph (a)—
  - (i) a copy of the Freight Bill of Lading;
  - (ii) a copy of the import cargo manifest clearly indicating the description of the cargo and the weight and measurements of the cargo in metric units.
- (d) demand production of a copy of a Certificate of Hold Reservation (hereinafter referred to as "A.R.C.") from an OGEFREM agent from the port of loading as proof that OGEFREM levy was collected at the port and where the goods

are not covered by A.R.C.; one point eight per cent (1.8%) levy shall be collected by the Merchant Shipping Superintendent in respect of the said goods pursuant of paragraph (a) of this notice; and

- (e) enforce the provisions of the said Agreement in accordance with the powers conferred upon him under section 313 of the Act or the provisions of any enabling regulations, rules or orders made pursuant to the Act.
