DECISION OF THE ELECTRICITY REGULATORY BOARD

In a letter dated 11th October 2000, the Complainant, through the firm of Mwaura Shairi and Company Advocates, referred a dispute to the Board for hearing under Section 87 (1) of the Electric Power Act, 1997 (the Act). The facts of the dispute given in that letter were that the Complainant was the registered owner of the premises known as LIMURU/BIBIRIONI/T.698 which premises were supplied with electricity by Kenya Power and Lighting Company Limited (the Licensee) in 1982/83; that from 1983 upto 1997 the Complainant paid his electricity bills on due dates; that on the 14th August 1997 the Licensee through its technician (one Mr. Kabiru) visited the Complainant's said premises, tested the Complainant's meter and soon thereafter replaced it with a new meter on the allegation that the Complainant's old meter had been tampered with; that by a letter dated 27th August 1997, the Licensee advised the Complainant that it had back-dated the Complainant's meter readings to May 1994 and debited the account with Kshs.206,110.20 being the alleged loss of revenue for the period May 1994 to July 1997; that KPLC thereafter disconnected electric power from the Complainant's premises for non-payment of the outstanding bill which as at 15th December 1999 allegedly stood at Kshs.281,287.50; that by a complimentary slip dated 12th February 1999, (not availed at the Hearing) the Licensee's Senior Customer Service Engineer (Mr. P.W. Njenga) instructed the officer in charge at the Licensee's Limuru Branch to reconnect power to the Complainant's premises and do the necessary adjustment to the Complainant's account, which instructions were never effected by the Limuru Branch office; and consequently, the Complainant was of the view that the Licensee in disconnecting electric power from the customer's premises acted in contravention of Sections 83, 84, 85(2) of the Act, and that the decision of the Licensee to debit the Complainant's account with alleged loss of revenue from May 1994 to July 1997 was arbitrary as there was no provision under the Act to arbitrarily and retrospectively back-date/speculate on a customer's energy on consumption.

On its part, the Licensee in a letter dated 19th July 2002, by way of a written submission to the Board, stated that the Complainant was its customer billed under account No 180102-01 served by meter

No. 9729262 located at Plot No. T698- Limuru-Uplands; that in early 1997 during a routine meter inspection exercise the Complainant's meter was found with broken meter seals which was an arrant sign of tampering; that the Licensee requested the Complainant to sign a liability form (not availed at the Hearing) to acknowledge the tampering but the Complainant declined; that after a protracted discussion with the Complainant, the Licensee resolved to install a check meter in order to use its reading to resolve the dispute; that a check meter was installed on 2nd July 1997 and the report thereof was sent to the Complainant vide a letter dated 27th August 1997; that the Licensee replaced the tampered meter number 250386 with meter number 9729262 on 15th August 1997; and that nine months consumption (August 1996 - April 1997) recorded by the tampered meter was 345 kWh while nine months consumption (October 1997 - June 1998) recorded by the new meter No. 9729262 was 10341 kWh that the lost revenue was computed and billed at Kshs.206,110.20; that the Licensee exchanged several correspondences with the Complainant on payment of the bill but the Complainant adamantly refused to pay; that the Licensee had no alternative but to disconnect the Complainant's supply and recover the meter; that it was not in dispute that the Complainant was fully involved in the process of checking the meter; that the Licensee acted within the provisions of the Act (Section 97) to calculate lost revenue; that the computed bill was correct and payable; that the assertion that meter No. 250386 was tampered with by the Licensee staff was not correct, given the circumstances, unless the Licensee staff did it as an agent of the Complainant who was the beneficiary; and that the Complainant was truly indebted to the Licensee in the sum of Kshs.281,525.00 being the unpaid electricity bill of Kshs.75,414.80 and the lost revenue due to meter tampering of Kshs.206,110.20; that meter No. 250386 had been tested in October 1992 at the Complainant's request and was found to be in a good condition, which did not necessarily imply that the meter remained throughout in that good condition; that tampering of the meter and the installation inspection in general were two different processes which were handled differently and the installation notice did not, therefore, include the meter attribute, although by this time the Complainant had already been informed about the meter tampering but declined to sign the liability form; that the check meter installed on 2nd July 1997 to test the meter confirmed that meter No. 250386 had actually been tampered with and hence under-recording; that the meter reading schedule for the 2 No. meter tabulated in the letter dated 19th July 2002 showed that the average consumption six months before the change of meter was 56 kWh while the average consumption for six months after the change of meter was 1087 kWh; that, therefore, it was very clear that the meter number 250386 had been interfered with; that furthermore the meter was connected to 24 No. rental units and one 2 bed roomed bungalow and taking the diversity in consumption for the different tenants, it was apparent that the meter was under-recording; that the debiting of lost revenue between May 1994 and September 1997 was not arbitrary as that was the period when there was a sharp drop in the Complainant's consumption, while the connected load had not changed, and that Section 97 of the Act allowed the Licensee to debit for the lost revenue resulting from a tampered meter.

By way of a written submission to the Board, the Complainant in a letter dated 24th July 2002, stated that meter No. 250386 was inspected in October 1992 and meter test report number 024754 dated 21st October 1992 forwarded to the Complainant, which meter was found to be

in good condition and not requiring a replacement according to meter test No. 024754 attached to the letter; that in late June 1997 or early July 1997 the Licensee inspected installations at the Complainant's premises and by a defective installation notice dated 9th July 1997, a copy of which was also attached, the Licensee advised the Complainant that his entire installation was faulty and required attention; that as at 9th July 1997 no allegation had been made by the Licensee that the Complainant's meter was faulty or had been tampered with by the Complainant even though the Licensee had already allegedly installed check meter No. 9729621 at the Complainant's premises on 2nd July 1997; that there was no evidence whatsoever that the Complainant's meter had been faulty and/or tampered with as far back as May 1994; that there was no evidence that the Complainant tampered with Meter No. 250386 in 1994 or 1997; that there was no legal justification for the Licensee to have debited the Complainant's account with back-dated, arbitrary and speculative charges for alleged under-charged units from May 1994 to September 1997; that the Complainant had always and promptly paid all his lawful bills to the Licensee from 1982 upto July 1997 but the Complainant was under no legal obligation to pay a fabricated bill of Kshs.281,525.00; and that the method employed by the Licensee to calculate its alleged loss was not provided for in the Act.

The Board gazetted the dispute for hearing on three occasions, that is on 20th July 2001, when the hearing was postponed due to changes in membership of the Board which occurred on 5th July 2001, on 7th August 2002 and 28th November 2002 when the hearing was postponed at the request of the Complainant and on 20th December 2002 for the present hearing, (9th and 10th January, 2003).

At the Hearing, the Complainant was in attendance and was represented by Mr. Mwaura Shairi, Advocate, and the Licensee by Beatrice Mwendo and Joshua Mutua, Chief Legal Officer and Commercial Cycle Manager, respectively. During interrogation by the Board, the Complainant submitted that the disconnection of the Complainant's electricity was unlawful because the Complainant did not tamper with the meter between May 1994 and July 1997 as alleged by the Licensee. He said that the *Meter Test Report* No. 024754 dated 21st October 1992 and a *Defective Installation Notice* dated 9th July 1997 showed that the Complainant's meter was in good condition in 1992, and that as at 9th July 1997 no allegations had been made by the Licensee that the Complainant's meter had been tampered with even though the Licensee installed a check meter number 9729621 at the Complainant's premises on 2nd July 1997, and that installation of the check meter on 2nd July 1997 was with an ulterior motive.

The Complainant further said that if the disputed readings were for the period 5th March 1995 to 14th July 1997, according to the Licensee's written supplementary submission dated 14th August 2002, there was no basis for the Licensee to claim lost revenue from May 1994.

He further said that computation and recovery of lost revenue by reason of the meter having been tampered with was not an option open to the Licensee under Section 97(1) which deals with the consequences of tampering with meters among other things, and in any event, the onus was on the Licensee to show that it had used an approved method to compute the amount claimed.

The Complainant, therefore, urged the Board to find that the

disconnection of electricity was unlawful and Kshs.281,525.00 was not owed to the Licensee.

Mr. Joshua Mutua, Commercial Cycle Manager for the Licensee, submitted during interrogation, that on 2nd July 1997 the Licensee's staff found the Complainant's meter with missing body seals which was evidence of meter tampering; that the Complainant was requested to sign a liability form admitting liability but declined; that a check meter No. 9729621 was installed on 2nd July 1997 and a report was furnished to the Complainant; and on 14th August 1997, the Complainant signed a liability form admitting to pay for the lost revenue. Mr. Mutua further said that the Licensee computed the lost revenue at Kshs.206,110.20 back-dated from May 1994 to July 1997, and urged the Board to find that the Complainant tampered with the meter and was liable to pay Kshs.281,525.00.

With regard to the liability form to pay for lost revenue, the Complainant claimed he did not read the form given to him by the Licensee's staff before signing it. He said that he read the form briefly and never saw the word "liability". He also said that he would not have signed the form if he knew it was self-incriminating. He relied on one Mr. Kabiru, the Licensee's staff's explanation that he would change the meter if he, the Complainant, signed the form, and further that if he did not sign the form, it would be an admission of guilt. Asked to explain further, he said that it would be admission that somehow, he had committed an offence with respect to the meter that was being replaced.

Questioned further by the Board on the evidence to corroborate his statement in his letter dated 10th September 1997, which was produced at the hearing, that lower bills were attributable to the collapse of a shoe-making enterprise, the Complainant denied the existence of any significant shoe-making factory in his compound, and said that the shoe-making enterprise referred to was only "a cobbler" tenant who did not use any energy save for two bulbs of 100 watts each, and therefore the cessation of the cobbler's business could not significantly affect the units recorded by the meter, in spite of the Complainant having stated in that letter that *"about a year back or so, a shoe-making enterprise within the compound collapsed after which our power bills fell significantly."*

Asked further by the Board whether the 24 units connected to the said meter as submitted by the Licensee in the supplementary submission dated 14th August, 2002, were included in his supply contract, the Complainant denied having 24 units on his compound and said that at that time there was "one block" occupied by pigs and another under construction. He did not, however, explain whether the "two, bulb cobbler" occupied the block under construction, the two bedroomed bungalow which he later mentioned, or the "one block" with the pigs.

In further response to questions, the Complainant stated that he disputed the check meter readings set out by the Licensee in its submissions. He explained that "two other meters" installed in 1999/2000 by Licensee's staff from the headquarters obtained different readings from the check meter installed by Mr. Kabiru in 1997, but the Complainant did not produce any bills pertaining to these "two other meters." He also referred the Board to his letter dated 23rd May, 1997, also produced at the hearing, in which he mentioned a check meter installed in 1995/96 when he noted noise coming from the meter and that the meter was found to be in working order but the Licensee did not issue a

meter test report, and the statement therein, which he reiterated, that he was advised by the Licensee to disconnect the deep freezer, cooker, water heater, washing machine and room heater during power rationing in 1996.

To another question, the Complainant explained that the meter No. 250386 used to have a metal device ("mabat") affixed to it part of which looked like "a chain". He stated that Mr. Kabiru pulled out the device with a nose pliers in the Complainant's presence. He further explained that if the "mabat" was the item referred to as the seal, then it was broken in his presence. He stated that he could not explain why Mr. Kabiru broke the "mabat" and the removal of this item was of no significance to him as a layman. Neither did he report the matter to the Licensee, because he believed Mr. Kabiru was doing his duty as an officer of the Licensee. He added further that he had no idea of the incentive for Licensee to do this if he, the Complainant was the beneficiary of this incident.

In response to questions put to the Licensee, Mr. Mutua explained that the Licensee's staff were trained in customer care; that staff knew their success depended on the customer who was not to be taken for granted; that the Licensee did not have records of the tests allegedly done to the Complainant's meter in 1995/1996; that he did not know whether the Complainant rectified the defects on his installation as required by the Licensee's "Defective Installation Notice" dated 9th July 1997; that it was the duty of the Complainant to rectify the defects and submit a wiring certificate to the Licensee from his contractor; that the Licensee did not receive any certificate to confirm that the defects were rectified, but that the Complainant continued to be on supply until disconnected in April 1999.

In further response to questions put to the Licensee, Mr. Mutua explained that the Licensee did not have records to show that the Complainant's meter was tampered with from May 1994 because the billing system changed in 1995, and prior records were not available.

Mr. Mutua said that no action was taken on the meter tampering of the Complainant's meter between May 1994 and July 1997 because the Complainant's premises may not have been visited during that period. He explained that in the past, customers were visited for inspection at three year intervals and that the period had since been reduced to yearly intervals after realization that the Licensee was losing a lot of revenue.

However, Mr. Mutua continued, check meter No. 972921 was installed on 2nd July 1997 for a period of 32 days and the check meter results were used to compute the Complainant's monthly average consumption at 1388 kWh, the chargeable units for the period May 1994 to July 1997 (30 months) at 54132 kWh, the undercharged units at 42089 kWh and the average monthly undercharge at 1079 kWh, and that the Complainant was also liable for the cost of a single phase meter, which, together with the computed cost of undercharged units added up to Kshs. 206,110.20 was debited to the Complainant's account as the cost of lost revenue for the period May 1994 to July 1997. The Licensee did not, however, produce the Meter Test Report for the challenged meter No. 250386 at the end of 32 days challenge period, and offered no explanation.

The Licensee did not also offer an explanation as to why the Licensee's automated systems or procedures did not detect the under-recording of meter No. 250386 for a period of 39 months (May 1994 - July 1997), even if the inspectors

were still waiting for three years to elapse before paying the Complainant the customary visits and discover the missing seals for meter No. 250386.

THE CONSIDERATION OF THE BOARD

It is not in dispute that the Complainant's premises were supplied with electricity from 1982/1983 to 1999, through old Account numbers 119582700 and 1603490, meter No. 250386 and new account No. 180102, meter No. 972962; that on 21st October 1992, the Licensee sent to the Complainant a meter test report No. 024754 confirming that his meter No. 250386 was in good working condition; that on 2nd July 1997 the Licensee installed a check meter No. 97291 in the Complainant's premises; and that on 9th July 1997 the Licensee sent to the Complainant a *Defective Installation Notice* requiring him to put his installation in order.

ISSUES IN DISPUTE

The main issues in dispute are first, whether the low average readings recorded by meter No. 250386 between November 1995 and July 1997 were due to meter tampering, and if so, by whom; second, if the meter No. 250386 was tampered with, the period to which the recovery of lost revenue should apply; and third, whether the Licensee has a right under the Electric Power Act to recover lost revenue by billing the Complainant.

Was Meter No. 250386 Tampered With?

In the correspondence preceeding the reference to the Board, the Complainant stated in a letter dated 23rd May, 1997, *inter alia*, that:

"2. At the height of power rationing in 1996 whereby every so often my lights used to fade culminating in total blackout my main switch emitted smoke as some neighbours used welding machines at night. I immediately switched off my mains and alerted KPL Limuru the following day.

I was advised to supply them with KBG (another switch ceramic type) which they themselves fitted, and power was again restored in my premises.

3. In the course of repairing, I enquired why my meter used to make a noise every so often, just before blackout.

Without much explanation, KPL Limuru simply advised me to disconnect whatever power consuming household equipment I got, till further notice otherwise, I was told I stood to suffer irreparable damages.

I immediately disconnected our deep freezer, the cooker, the water heater, the washing machine and the room heater. Upto now, I use power for lighting, radio, TV and occasional ironing only.

4. *It is therefore my sincere contention that KPL Limuru did assist me in lowering my monthly consumption not through meter 'tampering' but by my foregoing the aforesaid luxuries. To the best of my knowledge, your Limuru office did no more than switch replacing and since then nobody else has been to my meter board except your meter readers."*

The Complainant also stated in a letter dated 10th September 1997, inter alia, that:

- "iv. *Kindly note that since connecting me, I have had a steady expansion of physical structures with gradual increase in power consumption which I have always paid. Indeed by the time Mr. Kabiru came around late May 1997, one building was getting occupied, spelling a higher consumption thereafter. At the same time about a year back or so, a shoe making enterprise within the compound collapsed after which our power bills fell significantly.*

Finally I request you to confirm with your Mr. Kabiru that before installing his check meter, mine was in motion but after installing the check meter the old one went dead or static - a discrepancy he could not explain to me."

The Licensee also stated in his supplementary submission dated 14th August 2002, that meter No. 250386 was connected to 24 rental units and one 2 bedroomed bungalow.

From the letter of 23rd May 1997, it is evident that the Complainant was using the appliances mentioned therein, until power rationing in 1996.

From the letter dated 10th September 1997, it is evident that since 1982/83, physical structures on the Complainant's premises were "increasing" and consumption of power was also increasing. This corroborates the statement in the Licensee's submission on the 24 units and one bungalow, having been connected to meter No. 250386 and contradicts the Complainant's denial of the existence of these units, during interrogation by the Board.

None of the reasons given by the Complainant in his written submissions, in his letters dated 23rd July 1997, 10th September, 1997, 20th May, 1998, 12th April, 1998, or 20th August, 1998 or during the Hearing could explain the peculiar actual readings such as 0 kWh on 5th January 1996, -744 kWh on 9th May 1996, 20 kWh on 19th July, 1997, 24 kWh of 3rd September 1996, 26 kWh of 11th November 1996, or 30 kWh of 8th October 1996, to mention a few, compared to the actual readings of 650 kWh of 5th April 1995, 631 kWh of 5th June 1995 and 1873 kWh of 7th October 1997 and 1706 kWh of 12th November, 1997 of the same account.

Therefore, the Board finds, on a balance of probabilities, first, that meter No. 250386 was connected to several units, second, that the Complainant's consumption gradually increased from 1982/83 and third, that the low readings could only be the result of meter tampering sometimes after

September, 1995, and the Board rejects all of the Complainant's explanations.

Who Tampered with the Meter?

From the submissions of both parties, letters referred to at the Hearing, and answers to interrogation by the Board, the Board finds, on a balance of probabilities, that the meter No. 250386 was tampered with, by or on behalf of the Complainant, with the knowledge if not connivance with the Licensee's staff.

THE REGULATORY ISSUES

Is the Licensee Entitled to Recover the Lost Revenue Through Billing?

The Board has considered Sections 63, 86 and 97(1) of the Act in determining this dispute and finds that the Licensee is permitted by law to disconnect electricity to the Complainant for non-payment of any charge for electrical energy after giving not less than 14 days notice in writing to the Complainant; that the Licensee did not make any submission as to when the notice was served; that the Licensee is required under Section 86 of the Act to keep meters in repair but Licensee did not take any action on the tampered meter between October 1995 and July 1997; and that the language of Section 97(1) does not prohibit the Licensee from recovering lost revenue arising out of meter tampering through billing.

To What Period Should the Recomputed Readings Apply?

The Licensee back-dated lost revenue to May 1994 but only availed to the Board the readings of meter No. 250386 for the period March 1995 to March 2000, on the basis that records prior to March 1995 were not available. The Board does not find anomalous the actual readings taken on 5th April 1995 (576 kWh), 8th May 1995 (650 kWh) and 5th June 1995 (631 kWh) because there is no inexplicable deviation in the consumption trend as established by the Meter Test Report of 21st October, 1992. However, in July and August 1995, the readings were estimated at 811 kWh and 834 kWh respectively, and the actual reading of 5th September appears correct because it compensated the Complainant for the over-estimation. But from October 1995 the trend dropped from a monthly average of 565 kWh to below 100 kWh and so remained until July 1997, save for an adjustment to the October and November, 1995 readings. In the event, the Board finds that the earliest date from when the lost revenue can be recovered is December 1995.

Consequently, the Licensee ought to be compensated for the under-charged units during the period December 1995 to July 1997, in total 21,580 kWh, and for the cost of the new meter No. 9729622 which according to the prevailing tariffs and VAT rates entitles the Licensee to Kshs.114,268.40. The Board also noted the culpable conduct of the Licensee's staff and the laxity of the Licensee's internal controls to curtail such conduct, which contributed to the failure to recover this revenue as it fell due.

THE DECISION OF THE BOARD

1. The Complainant, Mr. Njuguna Kinyanjui, shall pay to the Licensee the sum of

Kshs.114,268.40 which the Licensee may debit to his account and recover forthwith.

2. The Licensee is hereby censured for neglecting to:

- (a) detect and take action on the tampered meter from December 1995 to July 1997.
- (b) Provide to the Board all meter test reports pertaining to this period, and records thereof prior to March 1995.
- (c) Comply with the legal requirement to give the Complainant notice before disconnection of his electricity supply.
- (d) Enforce compliance with the "Defective Installation Notice" issued to the Complainant on 9th July 1997.

3. The Licensee may reconnect electricity to the Complainant's premises in accordance with the Electric Power Act 1997 after payment of the amount of Kshs.114,268.40, but the applicable reconnection fee is waived due to the absence of the Notice of Disconnection by the Licensee to the Complainant.

4. The costs of gazettment of the Hearing Notice and the Decision shall be shared equally between the Licensee and the Complainant and paid to the Electricity Regulatory Board within thirty (30) days of the gazettment of this Decision.

**IMPORTANT NOTICE TO SUBSCRIBERS

- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—***Kenya Gazette***

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
