### THE LOCAL GOVERNMENT ELECTIONS RULES

#### NOTICE OF ELECTION OF COUNCILLOR

IN EXERCISE of the powers conferred by section 42A of the Constitution of Kenya, section 57 of the Local Government Act and rule 12 of the Local Government Elections Rules, the Electoral Commission gives notice that:

- (a) An election is to be held to determine the councillor to serve the Kanyaluo electoral area (ward) of County Council of Rachuonyo.
- (b) Each political party wishing to participate in the election must finalize the nomination of its candidates on or before 30th March, 2003.
- (c) The days for the nomination of the candidates for the councillor election will be on 31st March, 2003 and 1st April, 2003, and the nomination papers, which may be collected from the returning officer in whose jurisdiction the electoral area falls, may be delivered by the candidates to the returning officer concerned at between the hours of eight o'clock in the morning and one o'clock in the afternoon and between the hours of two o'clock and four o'clock in the afternoon of the days.
- (d) If the election is contested the poll will take place on 16th April, 2003.
