AWARD

On 27th November, 2001, the court summarily dismissed the preliminary objection raised by COTU (K) for its dilatory tactics or behaviour and non-prosecution, and ordered that it (COTU (K)) should file its reply statement to the union's main memorandum on or before 31st December, 2001, and the dispute was fixed for hearing on 17th January, 2002. COTU (K) neither filed its reply statement nor appeared during the hearing as aforesaid and no reasons were given for its failure to file its reply statement and non-appearance or absence. The dispute was therefore, heard *ex-parte* on the said date, i.e. 17th January, 2002.

Messrs. Joash Amukayia, Philip Abong'o, Bernard A. Ludeshi and Paul Irungu (who are hereinafter called the grievants) were employed by COTU (K) on diverse dates as accounts clerk, senior clerical officer, clerical officer-registry and accounts clerk-wages, respectively. On 30th October, 1995, the grievants were suspended from duty without pay, allegedly for committing "a serious gross misconduct and insubordination" and on 17th November, 1995, their services were terminated with effect from 16th November, 1995, on payment of one month's salary in lieu of notice. The union, however, interceded for the grievants, but no amicable settlement was reached between the parties. Consequently, the union reported a formal trade dispute to the Minister for Labour who accepted the same and appointed Wandeto to act as the investigator. The Minister released his report to the parties on 1st April, 1996, wherein he found that the termination of the grievants amounted to victimization and unfair labour practice, and for this reason he recommended "that all the four employees affected be reinstated back to their respective positions unconditionally with no loss of benefits or service". The Minister finally appealed to the parties to accept the recommendation as a basis of settling this dispute; and by his letter, dated 2nd May, 1996, the Secretary General of COTU (K), Joseph J. Mugalla, accepted the recommendation and requested the grievants to report to their place of work with immediate effect. But in a letter, Ref: COTU/CONF/PF/PA/9, dated the 29th July, 1996, the Deputy Secretary General of COTU (K), Boniface M. Munyao, advised the grievants, *inter alia* as hereunder:

"Ref: Reinstatement.

Please, we write to inform you that the Executive Board meeting held on 14th July, 1996, at Solidarity Building, reviewed your case aiming at reinstating you in your appointment in COTU (K) services. After a lengthy discussion, and consideration on the subject matter, the Board decided the following:

(a) That your appointment in the services of COTU (K) be reinstated with effect from 2nd May, 1996.

(b) That the period between 16th November, 1995, to 1st May, 1996, be treated as unpaid leave.

The union urged the court to find that the order of the Executive Board of COTU (K) that the period of the grievants' forced absence be treated as leave, without pay is unlawful, and that COTU (K) be directed to pay the grievants all their salaries and house allowances for the six months, amounting to KSh. 208,410 made up as follows:

In this case, the recommendation of the Minister for Labour was unconditionally accepted by COTU (K); and in the circumstances its order that the period of the grievants' absence from duty between 16th November, 1995 and 1st May, 1996, be treated as leave without pay is not supported by any rules or the sanction of the law. Hence of no legal effect. The spirit and intention of the labour laws is that employees who have been suspended or dismissed or terminated or removed, without any fault, and are reinstated, shall, be paid their full pay and allowances. The grievants were not found guilty of any charge or charges to warrant their termination from service; and accordingly they are deemed to have been on duty during the period of their suspension and termination and shall be entitled to the same wages and allowances as they would have received if they were not suspended and terminated from service. With the foregoing short discussion, I award and order that the grievants be paid their arrears of pay as tabulated hereinabove.

I have sought the advice or opinion of the members in making this award.
