**NOTIFICATION FOR KEIYO DISTRICT REPRESENTATIVES
BY-ELECTIONS**

BY-ELECTION is to be held for the replacement of one District Representative to serve in the National Constitutional Conference pursuant to the provision of section 27 (2) (c) of the Constitution of Kenya Review Act in respect of Keiyo District.

Pursuant to section 27 (2) (c) of the Act, each District shall have three representatives, at least one of whom shall be a woman and only one may be a councillor.

The by-election shall be held on 23rd April, 2003 between 9.00 a.m. and 4.00 p.m. at the Keiyo (Iten) County Council Meeting Hall.

Nomination forms for the elections may be obtained from the Secretary to the Clerk, Keiyo County Council on any day from the 10th April, 2003, between 9.00 a.m. and 12.00 noon.

Nomination papers may be returned by candidates to the returning officer at the Keiyo County Council Clerk's Office between 9.00 a.m. and 4.00 p.m. on the 16th and 17th April, 2003.
