TASK FORCE ON ANTI-MONEY LAUNDERING AND COMBATING THE FINANCING OF TERRORISM

APPOINTMENT OF MEMBERS OF THE TASK FORCE

IT IS notified for the general information of the public that the Minister for Finance has appointed a National Task Force on Anti-Money Laundering and Combating the Financing of Terrorism.

The Task Force shall consist of two representatives from each of the following—

- (a) Ministry of Finance;
- (b) Ministry of Trade and Industry;
- (c) Ministry of Foreign Affairs;
- (d) Central Bank of Kenya;
- (e) Police Department;
- (f) Criminal Investigation Department;
- (g) National Security Intelligence Service;
- (h) Bank Fraud Investigation Department;
- (i) Kenya Bankers Association;
- (j) Capital Markets Authority;
- (k) Commissioner of Insurance;
- (l) Kenya Revenue Authority; and
- (m) Immigration Department.

Terms of reference:

The terms of reference of the Task Force are—

- (a) to sensitize the public on the dangers of money laundering and financing of terrorism and measures to combat the menace;
- (b) to develop a national policy framework on anti-money laundering and combating the financing of terrorism;
- (c) to make appropriate recommendations through the policy framework to the relevant Government agencies on the national strategy to combat money laundering and terrorism;
- (d) to liaise with regional and international organizations in combating money laundering and the financing of terrorism;
- (e) to review existing legislation and make appropriate recommendations to the Attorney-General through the Minister for Finance on measures to ensure that the legislation is in tandem with combating money laundering and the financing of terrorism;
- (f) to attend to such other responsibility as may be assigned to it by the Minister for Finance.

The secretariat of the Task Force shall be based at the Central Bank of Kenya, Bank Supervision Department.
