The terms of reference of the task force are:

- (a) Review of all policy documents on Micro and Small Enterprises, including—
 - (i) Strategic plans;
 - (ii) Implementation plans;
 - (iii) Programme/activity reports; and Government of Kenya-Donor contracts and/or Memorandum of Understanding;
 - (iv) Any other relevant document with a view to safeguarding the interest of all stakeholders.
- (b) Review the Financial Reports on Micro and Small Enterprises Programme of the Ministry to assess their cost-effectiveness.
- (c) Assess the concerns of Jua Kali Industries (as presented to the Minister by Jua Kali Umbrella Associations with a view to recommending corrective action).
- (d) Review the effectiveness of various components of the Micro and Small Enterprises sector projects including the participation of Jua Kali in National and Regional marketing exhibitions and assess how they can be undertaken effectively without donor funding.

(e) Assess the extent to which umbrella Micro and Small Enterprises organizations are able to execute their mandate and roles in support of the members.

(f) Review the governance and institutional capacity of the Jua Kali organizations with a view to providing guidelines for any new project(s) designed to support the sector.

(g) Make policy and programme recommendations for enhancing Micro and Small Enterprises for job creation and economic growth.
