THE COMMISSIONS OF INQUIRY ACT

(Cap. 102)

THE COMMISSION OF INQUIRY INTO THE ILLEGAL AND IRREGULAR ALLOCATION OF PUBLIC LAND

RULES AND PROCEDURE

THIS Commission of Inquiry has been instituted pursuant to its appointment to inquire into the illegal and irregular allocation of public land as stated in Gazette Notice No. 4559 of 2003.

The Commissioners make the following rules for the conduct and management of the inquiry under section 9 of the Commissions of Inquiry Act.

Plenary Meetings of the Commission:

- (a) The Commission's plenary meetings shall be held at the Commission's official premises at Nairobi unless otherwise agreed. The public shall not be admitted at such meetings.
- (b) Subject to section 9 of the Act, the Commission shall meet at least twice a month.
- (c) The quorum for plenary meetings of the Commission shall be eight (8) commissioners.
- (d) The Chairman in his absence, the Vice-Chairman shall chair all plenary meetings. In the absence of both, the members, if they constitute a quorum, may appoint any present commissioner to chair the meetings.
- (e) If at the expiration of fifteen minutes from the time fixed for a plenary meeting, there is no quorum, the meeting shall be adjourned to such future time, as the Chairman shall appoint.
- (f) A motion of adjournment must be made and seconded and put to vote without undue delay.
- (g) All questions requiring to be decided by the Commissioners collectively shall be as far as possible be decided by consensus. Where no consensus is attained then such questions shall be decided by a majority of votes of the members present and voting. Provided that in the case of any equality of votes, the Chairman, or in his absence, the Vice-Chairman or the acting Chairman shall have the casting vote. Provided further that it shall be competent for any member to record his dissent from a majority decision.
- (h) Unless otherwise decided by the Commission the Chairman shall be the official spokesperson of the Commission.

Work and Organization:

- (a) To facilitate the conduct of its work the Commission may establish committees, as the demands of its mandate require.
- (b) Such committees shall devise their own procedures for the conduct of their work.

Hearings and Consultations:

- (a) In the discharge of its mandate the Commission may from time to time hold public hearings and consult such persons as it shall deem fit, and at such places and times as it may decide.
- (b) The quorum necessary for such hearings and consultations shall be three (3) commissioners.
- (c) The commissioners may direct that the public shall not be admitted to all or any specified part of such hearings and consultations, and subject to any direction, the proceedings shall be held in public, but the Commissioners may exclude any person or class of person from all or any part of the proceedings for any reason.
- (d) The Commission may summon any person or persons to testify on oath or to provide any information that it may require in the discharge of its mandate.
- (e) The Counsel assisting the Commission shall lead evidence relating to the inquiry at such public hearings.
- (f) The commissioners shall at any hearing, inform witnesses that after examination in chief they may also be cross-examined.

(g) Unless otherwise directed by the Commission for reasons to be duly recorded, any person/s who are the subject of adverse evidence affecting their reputation, character or conduct at a hearing, shall be given notice that they are entitled to appear in person or by advocate and to cross-examine any witness testifying thereto and to adduce evidence in refutation.

Evidence and Information:

- (a) The Commission shall receive evidence and information in the following forms:
 - (i) oral testimony under oath by question and answer method;
 - (ii) by way of affidavit or commission:
 - (iii) by way of written memoranda.

Provided that the Commission may require the deponent of an affidavit or the author of a memorandum to appear before it to clarify any issues arising therefrom, orally or further in writing.

- (b) The Commission may issue summons for the production of any documents, books, plans and all other documentation that the Commissioners may request.
- (c) In the receipt of any evidence the Commission shall conform to the provisions and restrictions contained in section 3 of the Commissions of Inquiry Act.

Reports.

- (a) Reports of the Commission shall contain reasons for all departures from the restrictions evidentiary or otherwise, contained in its terms of reference and the Commissions of Inquiry Act.
- (b) All reports required of the Commission shall be tabled for the consideration of and adoption of the Commission through its joint secretaries or the Chairman.
- (c) The final report of the Commission shall as far as possible be approved by all members of the Commission provided that a commissioner shall be entitled to submit to the President a minority report on any matter in regard to which he dissents from the views and conclusions of all or some of his fellow commissioners.

Disciplinary Matters:

- (a) Disciplinary matters concerning the commissioners or Commission staff shall be discussed and decided by the full Commission.
- (b) Where necessary, decisions arising therefrom shall be communicated by the Chairman to the President.

Declaration of Interest:

(a) In the event that a commissioner considers that a conflict of interest may arise in a matter under inquiry by the Commission, such commissioner shall be required to declare the possibility of such a conflict of interest in the matter to the Commission and to withdraw from further deliberations concerning the said matter should the Commission so decide.

Amendments to rules:

- (a) The Commission may in the course of its mandate amend, add to, repeal or otherwise adjust these Rules and Procedure as the demands of its work may require.
- (b) Such amendments shall require the support of no less than three quarters of the membership of the Commission.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE "KENYA GAZETTE"

THE following notes are for the guidance of persons submitting "copy," for inclusion in the Kenya Gazette, Supplement, etc.:

- The Kenya Gazette contains notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) Legislative Supplement contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.
- All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all-headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D— Kenya Gazette

- "D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) Ministries will be required to pay for the Kenya Gazette and to meet the cost of advertising in it.
- (3) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
