Members:

- (a) The Permanent Secretary, Secretary to the Cabinet and Head of the Public Service or his designated alternate, not being below the level of a Deputy Secretary;
- (b) The Permanent Secretary/Director of Personnel Management or his designated alternate, not being below the level of an Under Secretary;
- (c) The Permanent Secretary, Ministry of Finance or his designated alternate, not being below the level of an Under Secretary;
- (d) The Attorney-General or his representative;

- (e) The Secretary, Public Service Commission or his designated alternate, not being below the level of an Under Secretary;
- (f) The Inspector-General, State Corporations or his designated alternate, not being below the level of an Under Secretary;
- (g) A representative from the Disciplined Services nominated by the Chief of General Staff of the Armed Forces of Kenya, and not being below the rank of a Brigadier;
- (h) A representative of the public universities, not being below the level of Deputy Vice-Chancellor, nominated by the Minister for Education; and
- (i) The following persons to represent the private sector—

Josphat Mureithi Mutugi,
Geoffrey Aggrey Yonah Orao-Obura; and
John Karimi Njiraini,

Mark Kipkemoi Bor—(*Secretary of the Board*).

1. The functions of the Board shall be to—

- (a) continuously review the remuneration of persons in the public service and to make recommendations to the Government on the harmonization of remuneration in the entire public sector;
- (b) collect, collate and analyse information related to such matters as cost of living, housing, and principles behind payment of certain allowances;
- (c) study trends in remuneration pertaining to the private sector with a view to recommending ways of closing the gap between the private sector and the public sector;
- (d) undertake studies on factors affecting attraction and retention of staff in the public sector;
- (e) liaise with the relevant organs of Government to ensure that adequate budgetary provision is made for remuneration for public servants;
- (f) submit annual reports to Government on public sector remuneration; and
- (g) carry out such other functions as may, from time to time, be deemed necessary by the Government in the performance of its functions.

2. In the performance of its functions, the Board—

- (a) shall hold such number of meetings in such places and at such times as the Board shall consider necessary for the proper discharge of its functions;

- (b) shall receive views from members of the public and receive oral and/or written submissions from any person with relevant information;
- (c) may use official reports of any previous investigations relevant to its mandate;
- (d) may carry out or cause to be carried out such studies or research as may inform the Board on its mandate;
- (e) may co-opt any person into the Board as and when issues affecting specific areas of expertise arise; and
- (f) subject to the foregoing, the Board shall have all the powers necessary or expedient for the proper execution of its mandate, including the power to regulate its own procedure.

3. Secretariat of the Board:

The Secretariat of the Board shall be the Directorate of Personnel Management based in the Office of the President.
