## DECLARATION OF MONUMENTS

IN EXERCISE of the powers conferred by section 4 (1) (a) of the Antiquities and Monuments Act, the Vice-President and Minister for Home Affairs, declares the sites specified in the schedule, which he considers to be of historical interest, to be monuments within the meaning of the Act.

## INTERPRETATION APPLICATION I TO 61 OF 1998

## Parties:

Kenya Engineering Workers Union—(Applicants)

and

Warren Enterprises Limited—(Respondents)

THE Court announced its award on 28th January, 1999 and the union made an application for interpretation of the court award on 23rd April, 1999.

The application on the statutory form "F" duly signed by the General Secretary on behalf of the union was received by the court on 28th April, 1999.

The parties were heard on 23rd June, 1999 and relied on their written and verbal submissions.

## BACKGROUND

This cause revolves around one Silas Mugosi and 19 other former unionisable employees of the Warren Enterprises Limited (Respondents) whose employment was terminated on 5th December,

1997. In cause No. 61/98 the court awarded Mugosi and the 19 other employees two months salary each by way of compensation in addition to their terminal dues already offered by the respondents. The above award was made on 28th January, 1999.

While cause No. 61/98 was being heard the CBA for the period 1st September, 1994 to 31st August, 1996 had already expired and the parties had started negotiations for a new CBA for the period from 1st September, 1996 to 31st August, 1998.

The dismissal of Mugosi and the nineteen (19) employees took place shortly before the 1996/98 CBA had been concluded. The issue to be decided now by way of interpretation is whether Mugosi and 19 employees dismissed with him should be paid their terminal dues awarded by the court in accordance with the 1994/96 CBA or the 1996/98 CBA provisions.

The claimants want the calculation of final payments to be based on 1996/98 CBA provisions while the respondents want to use the 1994/96 rates. The claimants also want each of these employees to be paid their gratuity entitlement.

The respondents stated that the 1996/98 CBA was negotiated and eventually concluded in October, 1997, and was signed by the parties on 20th November, 1997 while the grievants were still in the service of the respondents. Their dismissals took place on 5th December, 1997. However, the 1996/98 CBA was registered in court on 12th December, 1997 i.e. after the dismissals which took place on the 5th December, 1997.

It is to be noted that in the Award referred to above, the court did not state whether the final dues of the grievants should be calculated using the 1994/96 or 1996/98 CBA rates.

The respondents submitted that the grievants who were the subject of the court award in Cause No. 61/98 were dismissed on 5th December, 1997 while the CBA for 1996/98 was accepted for registration by the court on 19th December, 1997. The further averred that the Trade Disputes Act expressly provides at section 16 (2) that an award of the court shall be published in the *Kenya Gazette*, and shall take effect on the date of such publication.

They further stated that the Act also provided at section 13 that it is an offence to implement a Collective Agreement that has not been accepted or registered by the Industrial Court.

#### RULING

In view of the special circumstances of this dispute and considering the fact that the workers were dismissed on 5th December, 1997 and the CBA for the years 1996/98 was registered by the court on 19th December, 1997, it would be stretching to an absurdity the legal technical point that the workers should be deprived of their arrears for nearly two years simply because the agreement was registered twelve (12) days after they were sacked.

It should be borne in mind that the 1994/96 CBA had expired more than one year before the grievants were dismissed. There seems to be no logic in trying to apply 1994/96 rates at the end of 1997 when the new rates under 1996/98 agreement are effective from 1st September, 1996.

The court will not allow bare legal technicalities to defeat ends of justice. The court accordingly rules that the terminal benefits should include the arrears due to the workers.

The matter of payment of gratuity is rather different. The workers lost their jobs on disciplinary grounds and taking into account all the surrounding circumstances the court rules that they are not entitled to gratuity.
