NOTIFICATION FOR TESO DISTRICT REPRESENTATIVE BY-ELECTION

BY-ELECTION is to be held for the replacement of one District

Representative to serve in the National Constitutional Conference pursuant to the provision of section 27 (2) (c) of the Constitution of Kenya Review Act in respect of Teso District.
