## ELIGIBILITY TO ENTER

- Kenya citizens who are serving as Telephone Operators Grade II in the Civil Service and are confirmed in their appointment and admitted to permanent and pensionable establishment with at least three (3) years service in that grade; or
- Other Telephone Operators in an equivalent grade in the Public Service.

## CONDITIONS FOR PASSING THE OCCUPATIONAL EXAMINATION TESTS

In order to pass any of the Occupational Examinations, a candidate is required to pass both the written English (or Oral English Examination in the case of Blind Operators) and the Practical Examination at one sitting. However, candidates with partial passes will be referred to re-sit only in the part failed in the Examination.
