On 5th March, 2003, the Minister for Labour referred this dispute to the Court for consideration and determination under powers vested in him by section 8 of the Trade Disputes Act, Cap. 234 of the laws of Kenya (which is henceforth referred to as the Act); and his reference, together with the statutory certificates from the Labour Commissioner and the Minister himself under section 14 (9) (e) and (f) of the Act, were received by the Court on 7th March, 2003. Mwari for the Union submitted his main memorandum on 22nd May, 2003, and Basilio, the learned counsel for the hospital, filed his reply statement thereto on 15th June, 2003. The dispute was heard on 25th July and 16th October, 2003, but the parties were given an opportunity to explore the possibility of any amicable settlement out of court.
