#### **SUSPENSION OF REGISTRATION OF VOTERS**

IN EXERCISE of the powers conferred by section 28 (1) of the Constitution of Kenya Review Act (Cap. 3A) and Regulation 9 (4) of the Constitution of Kenya Review (Referendum) Regulations, 2005, the Electoral Commission of Kenya notifies that the registration of voters (including transfers of the registration of voters) is suspended until after the 21st November, 2005.

### **THE CONSTITUTION OF KENYA REVIEW (REFERENDUM) REGULATIONS, 2005**

#### **NOTICE OF REFERENDUM**

IN EXERCISE of the powers conferred by section 28 (1) of the Constitution of Kenya Review Act (Cap. 3A) and Regulation 9 of the

Constitution of Kenya Review (Referendum) Regulations, 2005, the Electoral Commission of Kenya specifies by this notice the following, namely:

- (a) It is notified that a referendum will be held on the Proposed New Constitution of Kenya on the 21st November, 2005 from 7.00 a.m. to 5.00 p.m.
- (b) The question to be voted upon in the referendum is as follows—

**"ARE YOU FOR OR AGAINST THE RATIFICATION OF  
THE PROPOSED NEW CONSTITUTION?"**

- (c) Any person or group of persons wishing to campaign during the referendum period must form a referendum committee and register with the Electoral Commission of Kenya before the 15th October, 2005.
- (d) The referendum period within which any person or referendum committee supporting or opposing the referendum question may carry out campaigns to support or oppose the referendum question shall be between 21st October, 2005 and 19th November, 2005, and not earlier.
- (e) All campaigns in support of or against the referendum question shall cease twenty-four hours before 7.00 a.m. of the polling day.
- (f) Every referendum committee participating in the referendum shall subscribe to and abide by the Electoral Code of Conduct as provided for under section 34A of the National Assembly and Presidential Elections Act as set out in the Fourth Schedule thereto.

*Note.*—The Proposed New Constitution was published as Kenya Gazette Supplement, 2005, on 22nd August, 2005.
