- 2. High water demand.
- (a) Diversity water sources for different uses.
- (b) Harness rainwater for domestic use and gardening.
- (c) Install water conserving taps that turn off automatically when water is not being used.
- (d) Ensure bore holes not within 800 metres apart and ensure monitoring of the ground water.
- (e) Promote recycling and reuse of water as much as possible.
- (f) Use high pressure clean up system.
- 3. Health and safety issues
- Make a health and safety policy covering noise, accidents and accident reporting systems, working environment, workstations, PPE, including responsibilities at different levels, training, machines and equipment, supervision, health and safety training requirements.

Mitigation measures

4. Solid and liquid waste generation

- (a) Use an integrated solid waste management system i.e. source reduction, recycling, composting and reuse, sanitary land filling.
- (b) Put solid waste containers at convenient points to avoid littering.
- (c) All construction debris to be dumped into area designated by the Kisumu Municipality.
- (d) A large septic tank to be designed and constructed.
- (e) Waste stabilization ponds, with a septic tank serving the role of an anaerobic pond.

5. Air, dust and noise pollution

- (a) Personal protective clothing and equipment to be bought and to be mandatory worn.
- (b) Avoid excavation works in extremely dry weather.
- (c) Sprinkle water on graded access routes when necessary to reduce dust during construction.
- (d) Ensure that all generators and heavy-duty equipment are insulated or placed in enclosures to minimize ambient noise levels.
- (e) Encourage planting of plant species known to absorb smell.
- Sewerage to be channelled to the waste water treatment system .
- (g) Construction activities to be restricted to daytime.

6. Fire hazards

- (a) Install fire equipment in premises, and more units in more risky environments
- (b) First aid kit with a first aider, and an appointed person(s); conduct fire drills on regular basis.
- 7. Prostitution and contraction of (a) Have voluntary counselling and STDs, including HIV/AIDS related
  - testing.
  - (b) Initiate ad run a college stayalive program that is run by both staff and students.
  - (c) Get and distribute free high quality condoms to all students.
  - (d) Organize peer counselling session and programs.
