## NATIONAL CROP VARIETIES INDEX

IN EXERCISE of the powers conferred by Section 7 of the Seeds and Plant Varieties Act, the Minister for Agriculture, after consultations with representatives of such organisations deemed fit to have substantial interest in the matter to be regulated, and such other interests as appear to the Minister to be concerned, publishes the provisional list of the National Crop Varieties Index.

*Definitions*

'authorised officer' means the Managing Director of the Kenya Plant Health

Inspectorate Service (LN. No. 305/1996).

'maintainer' means the owner or individual or institution charged with maintaining the plant variety by the owner, in its original form.

'owner' means an individual or institution which bred the plant variety.

'variety name' means an official name under which the plant variety has been released and registered and which can be used for commercialization.
