## OFFICE OF THE PRESIDENT

### THE NATIONAL CAMPAIGN AGAINST DRUG ABUSE IN KENYA

#### APPOINTMENT OF AN ADVISORY BOARD

IT IS notified for the information of the general public that, I, Mwai Kibaki, President and Commander-in-Chief of the Armed

Forces of the Republic of Kenya, have established a Board to be known as the National Campaign Against Drug Abuse Advisory Board.

#### 1. (1) The Board shall consist of—

- (a) Chairman appointed by the President; and
- (b) The following other members—
  - (i) The Permanent Secretary, Office of the President, Provincial Administration and Internal Security or his representative;
  - (ii) The Permanent Secretary, Ministry of Health or his representative;
  - (iii) The Permanent Secretary, Ministry of Education or his representative;
  - (iv) The Permanent Secretary, Ministry of Youth Affairs or his representative;
  - (v) The Permanent Secretary, Ministry of Planning and National Development or his representative;
  - (vi) Two representatives of religious organizations appointed by the Minister for the time being responsible for matters relating to the campaign against drug abuse;
  - (vii) Two youth representatives appointed by the Minister;
  - (viii) One representative nominated by the Medical Practitioners Board; and
  - (ix) Not more than three members co-opted by the Board by virtue of their expertise in matters relating to drugs and drug abuse;
  - (x) A National Coordinator who shall be the Chief Executive and Secretary to the Board.

(2) The members of the Board shall be in office for a term of three (3) years but will be eligible for re-appointment once.

#### 2. The Functions of the Board shall be to—

- (a) Develop legal and institutional framework for control of drug abuse;
- (b) Co-ordinate public education campaign against drug abuse;
- (c) Mobilize resources for drug abuse control and prevention;

- (d) Develop mechanism in collaboration with key stakeholders for curbing drug abuse in schools and other Institutions of learning;
  - (e) Develop an action plan on curbing drug abuse by the youth;
  - (f) Facilitate the setting-up of rehabilitation facilities for drug dependant persons; and
  - (g) Submit annual reports and recommendations to the Minister for the time being responsible for matters relating to drug abuse;
  - (h) The Board may open offices at the Provincial or District level to facilitate implementation of its mandate;
  - (i) Perform any other function incidental to the foregoing
3. In the performance of its functions the Board—
- (a) Shall hold such number of meetings in such places and at such times as the Board shall consider necessary for the proper discharge of its functions:

Provided that whenever such meetings are held in places other than the normal place of meetings and where additional allowances are to be paid, permission to hold such meetings shall be sought from the Permanent Secretary responsible for the Board's finances.

- (b) May use official reports of any previous investigations relevant to its mandate;
  - (c) May carry out or cause to carry out such studies or research as may inform the Board on its mandate; and
  - (d) Subject to the foregoing, the Board shall have all the powers necessary or expedient for the proper execution of its mandate, including the power to regulate its own procedure.
4. The Secretariat of the Board
- (1) The Secretariat of the Board shall be based in Nairobi and shall consist of—
- (a) (i) A National Co-ordinator who shall be appointed by the Minister from among three candidates recommended by the Board, and
  - (ii) Such number of staff as shall be deemed appropriate by the board for the better performance of their functions.
  - (b) The National Co-ordinator will serve on contract with the Board for a period of three years renewable only once subject to the terms and conditions of the contract, and
  - (c) The National Co-ordinator shall be responsible for the carrying out of the functions set out in sub-paragraph (2) of this paragraph; and
- (2) The Secretariat of the Board shall be responsible for—
- (a) Providing appropriate background briefing to the Board;
  - (b) Preparing the Board's agenda, reports and disseminating any information deemed relevant to the Board;
  - (c) Undertaking research and liaising with Research Institutions in order to gather and disseminate the relevant information necessary for creation of public awareness, and for that purpose, may engage the services of consultants;
  - (d) Performing any other assignments as may be assigned from time to time by the Board in the exercise of its mandate.

#### 5. Funding

- (1) Through the Board's activities and cost of personnel shall be funded through the regular annual government budget on grant basis.
- (2) The Board may also mobilize and receive grants from donors to finance any of planned activities.
- (3) All funds received as grants shall be fully accounted for.

APPOINTMENT OF THE LOCAL ORGANIZING COMMITTEE FOR THE 2007 INTERNATIONAL ASSOCIATION OF ATHLETICS FEDERATION (IAAF) WORLD CROSS COUNTRY CHAMPIONSHIPS

IT IS notified for general information that following the successful bid by Kenya to host the 2007 International Amateur Athletics Federation (IAAF) World Cross Country Championships ("the Championships") in Mombasa, the Minister for Gender, Sports, Culture and Social Services has appointed a committee to be known as the Local Organizing Committee for the Championships, comprising—

1. Rachel B. Ozombo (Mrs.), Permanent Secretary, Ministry of Gender, Sports, Culture and Social Services—(Chairman),

Shariff Ali Shekue, His Worship The Mayor of Mombasa—(First Vice-Chairman),

Lt.-Gen. Jackson Tuwei, Commandant, Kenya National Defence College—(2nd Vice-Chairman);

2. The Chairman shall chair all the meetings of the Committee and in his absence, the 1st Vice-Chairman shall chair, and in the absence of the 1st Vice-Chairman the 2nd Vice-Chairman shall chair, or in the absence of both the Chairman, the 1st and 2nd Vice-Chairman the members present shall elect a member of the Committee to chair the meetings.

3. The functions of the Committee shall be to—

- (a) promote and market Mombasa, Kenya as a destination for the Championships;
- (b) use all resources, means and efforts to market the country as a peaceful and suitable environment for tourism and sports generally;
- (c) utilize the image of Kenya as a sporting and politically stable country for the promotion of Mombasa as the best possible destination for the Championships; and
- (d) Offer the best possible organizational framework meeting international standards for the hosting of the Championships in Africa generally and in Mombasa, Kenya in particular.

4. (1) In the performance of its functions the Committee shall—

- (a) with the approval of the Minister open and operate a banking account or banking accounts for the funds availed to it;
- (b) administer the assets and funds availed to it in such manner and for such purposes as shall promote the task for which it has been appointed, and
- (c) receive gifts, donations, grants or other money and equipment and make legitimate disbursement therefrom.

(2) Subject to the foregoing the Committee shall have all the powers necessary or expedient for the proper execution of its mandate, including the power to regulate its proceedings.

5. The Committee shall have the following sub-committees—

- (a) The Fundraising Sub-Committee, under Titus Naikuni as Director, which shall be responsible for co-ordinating, energizing, motivating and promoting fundraising among all well-wishers, sponsors and the Government of Kenya for the Championships.
- (b) The Finance Sub-Committee, under Julius M. Mwangi as Director, which shall be responsible for ensuring prudent management of whatever funds raised in a transparent manner, ensuring in this regard that all proceeds raised for the purpose of the Championships are accounted for and reports presented to the Minister responsible for Sports after every three months or from time to time as the Minister may require.
- (c) The Logistics Sub-Committee, under Isaiiah Kiplagat as Director, which shall be responsible for—
  - (i) co-ordinating, establishing, implementing, supervising, monitoring and evaluating all necessary logistics for the Championships to the satisfaction of the IAAF and participating countries;
  - (ii) guiding all other Sub-Committees on IAAF procedures and requirements, and
  - (iii) signing IAAF documents relating to the Championships.
- (d) The Marketing Sub-Committee, under Sam Mwai as Director which shall be responsible for—
  - (i) undertaking, supervising, monitoring, controlling and motivating the marketing of the Championships event internationally throughout the period, and
  - (ii) managing all advertising relating to the Championships;
- (e) The Media and Publicity Sub-committee, under Bitange Ndemo (Dr.) as Director, which shall be responsible for generating interest in the championships or otherwise convincing media houses and the consumer audience to broadcast, disseminate and give publicity to the Championships in the run-up to the thereto, during the actual event and thereafter;
- (f) The Technical Sub-Committee, under John Velzian as Director, which shall be responsible for—
  - (i) establishing, promoting and supporting all technical aspects of the Championships, including training, course-design, programmes for the event, competition, technical regulation, sport operations, warm-up facilities and equipment, and
  - (ii) any other matter incidental to or relating to the foregoing;
- (g) The Tourism Sub-committee, under Rebecca Nabutola (Mrs.) as Director, which shall be responsible for—
  - (i) promoting and marketing Kenya as a leading tourism destination in Africa, and
  - (ii) undertaking any other matter incidental to or relating to the foregoing;
- (h) The Medical Sub-Committee, under James Nyikal (Dr.) as Director, which shall be responsible for—
  - (i) establishing and supporting the facilitation, provision and supply of medical facilities for athletes and officials, and

- (ii) doping control and testing and provision of any other emergency health services.
- (i) The Security Sub-Committee, under Maj. General Mohammed H. Ali as Director, which shall be responsible for—
  - (i) establishing, providing and monitoring modalities for security in consultation with all security agencies, locally and internationally for guests, athletes, staff, media, sponsors and spectators, and
  - (ii) instituting security measures to minimize the negative impact if any, of the event on the normal economic and social life of the local community.
- (j) The Operations Sub-Committee, under the 1st Vice-Chairman as Director, which shall be responsible for—
  - (i) setting specific terms of reference for the Secretariat staff, including determining remuneration for staff at the Secretariat of the committee;
  - (ii) assigning specific tasks to members of the Secretariat and setting up specific structures for the successful operations of the Committee and the Sub-Committees, and, in particular, setting up a Secretariat in Mombasa to ensure smooth operations of the Championships, and
  - (iii) undertaking any other task incidental or relating to the foregoing.

The other members of the Operations Sub-Committee shall be—

Isaiah Kiplagat;  
David Okeyo;  
Joshua Okuthe;  
Gordon Oluoch;  
Sam Mwai, and  
Isaac Kalua.

6. The Commissioner for Sports, Gordon Oluoch, shall be an *ex officio* member of the Committee and all other sub-Committees, and shall guide the Committee on technical and Governmental requirements and procedures.

#### 7. The Organogram of the Committee—

The organizational structure of the Committee shall be as set out in the Schedule.

#### 8. The promoters of this project are:

- (a) The Government of Kenya which shall—
  - (i) be the host of the Championships, and
  - (ii) guide, fund, assist, support, motivate and facilitate the Committee;
- (b) Athletics Kenya (as an affiliate of the IAAF) which shall—
  - (i) support, market, promote, motivate and encourage the IAAF members' participation, and
  - (ii) undertake any other matter related to the foregoing;
- (c) The City of Mombasa which shall—
  - (i) host the Committee during the promotion of the event, and
  - (ii) support, popularize, culturalize and mobilize local investors to partner in the successful promotion of the Championships event;

#### 9. The term of office of the Committee.

The Committee and its Sub-Committee shall be in office with effect from the 13th November, 2005 until the end of six months from the end of the Championships.

#### 10. Winding-up of the Committee.

- (1) Upon the completion of its work in accordance with the foregoing sections, the Committee shall—
  - (j) organize an event to express appreciation to the Government, supporters and well wishers and show appreciation to local participants;
  - (k) compile a report and prepare audited accounts to be submitted to the Minister responsible for Sports, and

- (l) Surrender all outstanding assets, including credit balances in bank account and moveable assets to the Government through the Minister responsible for Sports.

(2) If for any reason the opportunity to host the IAAF Cross Country Championships is terminated, the Committee and its Sub-committee shall wind up their operations by submitting a written report to the Minister responsible for Sports, within a period of three months after such termination.

11. The spokesperson of the Committee shall be David Okeyo, who shall undertake the task in liaison with the Chairman of the Committee and the Chief Executive Officer of the Committee.

#### 12. The Secretariat of the Committee.

(1) The Secretariat of the Committee shall be based at Nyayo National Stadium, Swimming Complex 115, P.O. Box 3405-00506, Nyayo Stadium, Nairobi, Kenya and shall consist of—

- (a) a chief executive officer appointed by the Minister responsible for Sports, who shall be responsible for carrying out the functions set out in paragraph (2), and
- (b) such number of staff as shall be deemed appropriate by the Committee, who shall be provided by the Ministry.

(2) The Secretariat of the Committee under the general direction of the chief executive officer shall be responsible for—

- (a) providing appropriate background briefing to the Committee and the Sub-Committees;
- (b) supervising and controlling the day-to-day operations of the Committee and the Sub-Committees;
- (c) preparing the Committee's report and disseminating information deemed relevant by the Committee;
- (d) recommending the hiring of technical staff or any other such staff as may be deemed appropriate for the purpose of the Committee;
- (e) preparing the budgets and accounts of the Committee and the Sub-committees;
- (f) ensuring, in consultation with the Chairman of the Committee and the Chairman of the Finance and Fundraising Sub-committees prudent management of all the funds of the Committee;
- (g) overall co-ordination of all the activities of the Sub-Committees;
- (h) co-ordinating the activities of the Committee and in particular ensuring liaison with the Chairman of the Committee and Directors of the various Sub-Committees;
- (i) matters relating to protocol, public relations and procuring consultancy services for the Committee and the Sub-Committees;
- (j) organising and co-ordinating travel and accommodation for members of the Committee and the Sub-Committee;
- (k) setting up the games administration centre;
- (l) communicating with IAAF and other partners in consultation with the Chairman and Athletics Kenya, and
- (m) performing such other assignments as may be assigned from time to time by the Committee in the exercise of its mandate.

#### 13. Funding

(1) The activities of the Committee shall be funded through the regular Government budget on grant basis.

(2) The Committee may also receive grants from well-wishers and sponsors to finance any of its planned activities.

(3) The chief executive officer shall forward to the Minister at least once every three months a report on the expenditure of the Committee.

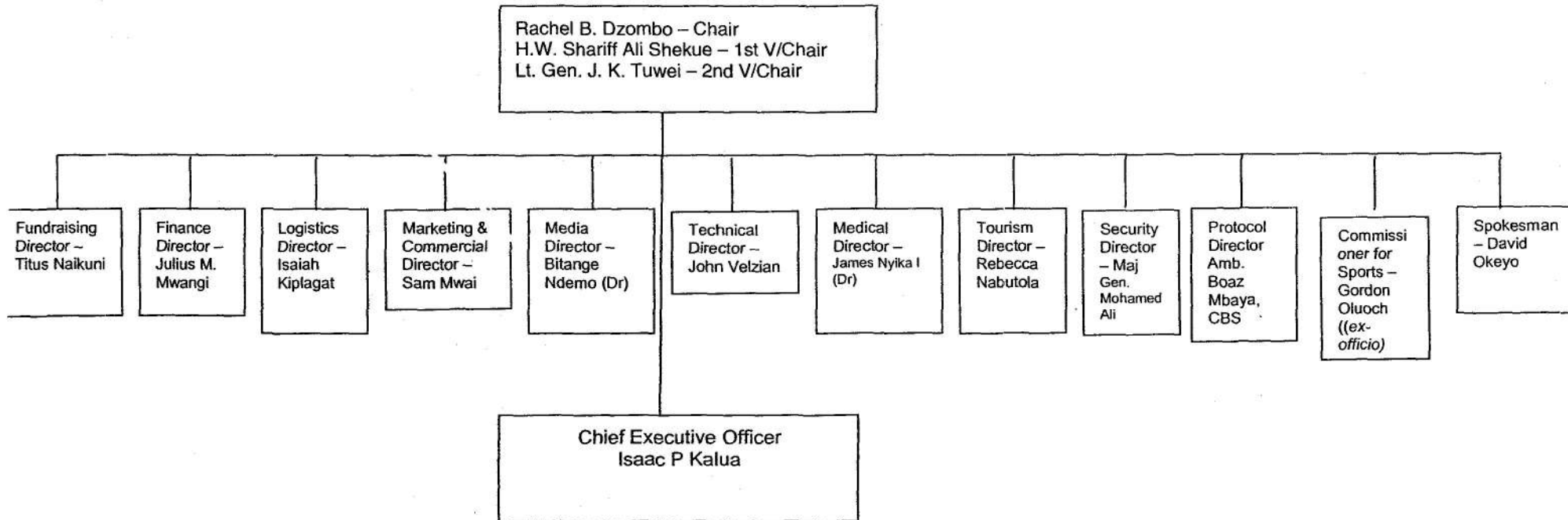
