

THE GRANTS YOUTH ORGANIZATIONS PROGRAMME GRANTS TO YOUTH

1. IT IS notified for general information that the Ministry of State for Youth Affairs has established a "Grants to Youth Organizations-Programme" to be administered by a National Grant Committee under the Chairmanship of the Permanent Secretary for the time being responsible for Youth Affairs. The establishment of the Programme has been necessitated by the generally inadequate capacity of youth organizations to attract finances and to implement projects effectively and efficiently. The Ministry invites the participation and support of government ministries and departments, state corporations, development partners, private sector organizations, civil society and individuals to supplement the ministry's efforts by availing training and technical expertise as well as financial and other resources to the youth through the Grants to Youth Organizations Programme.

- 2. The objectives of the Grants to Youth Organizations Programme
 - (a) Enable youth groups to scale up innovative projects that have a high social impact in the areas of HIV/AIDS, environmental conservation and poverty reduction that can be replicated elsewhere.
 - (b) Support capacity building in youth organizations through the provision of life skills and leadership training.
 - (c) Facilitate training of youth groups in entrepreneurship and business skills as well as providing seed money to bring them to the level where they can qualify for loans from the Youth Enterprise Development Fund.
 - (d) Support any other form of youth venture, which the National Committee deems as contributing to the development of a patriotic, empowered and productive youth.

Operation of the Grants to Youth Organizations Programme:

- 2. A National Grant Committee at the headquarters and Grant Committees at the district level will oversee the governance of the grants programme. All applications for funding will be routed through the District Grant Committees except where the provision is waived by the Chairman of the National Grant Committee. At the national level, the membership of the Grant Committee will comprise of the following:
 - (a) The Permanent Secretary, Ministry of State for Youth Affairs as the Chairperson.
 - (b) The Permanent Secretary, Office of the President/Provincial Administration and Internal Security or his representative.
 - (c) The Permanent Secretary, Ministry of Finance or his representative.
 - (d) The Permanent Secretary, Ministry of Gender, Culture, Sports and Social Services of his representative.
 - (e) A representative of the National Youth Council, appointed by the Minister, who shall serve for a term of two years renewable once.
 - (f) Three other members, not being public officers, appointed by the Minister for Youth Affairs on account of their expertise and interest in youth development, who will serve for a term of two years renewable once.
 - (g) The Director in charge of Youth Development as Secretary.
- 3. Membership of the District Grant Committee will comprise of:
 - (a) The District Commissioner, who shall be the chairperson.
 - (b) The District Youth Development Officer as Secretary.
 - (c) The District Youth Training Officer.
 - (d) The District Social Development Officer.
 - (e) The Chairman of the District Youth Council or his representative.
 - (f) Three other persons co-opted by the District Grant Committee on the recommendation of the District Youth Development Officer on account of their expertise and interest in youth development. Such persons, at least one of who must be female, will serve for a period of two years and are eligible for reappointment once.
- 4. All organized youth groups in Kenya may apply for the funds through the grants programme by satisfying the following criteria. The group must:
 - (a) Be registered as a youth group with the Department of Social Services, the Attorney-General or be a local chapter of a legally registered national youth organization. Where the membership of a group is mixed in terms of age, more than 70 per cent of its members must be below 30 years old.
 - (b) Hold a bank account that has been active for a period not less than six months.
 - (c) Be working in the area of environment, youth empowerment, health or enterpreneurship programmes for youth.
 - (d) Be ready to submit the required information in the prescribed application format.
 - (e) Be applying for funds to scale up activities that have been ongoing for at least six months.

- (f) Be seeking funds of not more than 300,000 per application for organizations whose activities do not cover more than one province. TOGOMATOR
- (g) Keep basic books of accounts and accountable documents.
- (h) Be ready to undertake to submit a project completion report.
