### **APPOINTMENT OF THE LOCAL ORGANIZING COMMITTEE FOR THE 2010 INTERNATIONAL ASSOCIATION OF ATHLETICS FEDERATIONS (IAAF) SENIOR AFRICAN ATHLETICS CHAMPIONSHIPS**

1. IT IS NOTIFIED for general information that following the successful bid by Kenya to host the 2010 Confederation of African Athletics (CAA) Senior Athletics Championships ("the Championships") in Nairobi, the Minister for Youth Affairs and Sports has appointed Committees to be known as the Steering Committee and Local Organizing Committee for the Championships consisting of:-

2. The Chairman of each Committee shall chair the meetings of the committee and in their absence, the Vice Chairman shall chair and in the absence of both, the members present shall elect a member of the Committee to chair the meeting.

3. The functions of the Steering Committee shall be to offer the best possible organizational framework, meeting international standards for hosting the Championships in Nairobi.

4. The term of Office for the Committees and Secretariat:

The Committees and the Secretariat shall be in office with effect from 1<sup>st</sup> July, 2009 until ninety (90) days from the end of the championships.

5. Winding up of the event:

Upon the completion of its work in accordance with the governing regulations, the Committees shall organize an event to express appreciation to the Government and supporters, and well wishers and show appreciation to local participants.

6. The Secretariat:

a) The Secretariat of the Committee shall be based at Nyayo National Stadium, Nairobi, Swimming Complex 115, P.O. Box 3405 - 00506 Nyayo Stadium, Nairobi, Kenya and shall consist of:-

➤ A Chief Executive Officer appointed by the Minister responsible for Sports, who shall be responsible for carrying out the functions set out in paragraph (3), and

➤ Such number of staff as shall be deemed appropriate by the Committee, who shall be provided by the Ministry.

b) The Secretariat of the Committee under the general direction of the Chief Executive Officer shall be responsible for:-

i. Providing appropriate background briefing to the committee and the sub-committees;

ii. Supervising and controlling the day to day operation of the committee and sub-committees;

iii. Preparing the Committee's report and disseminating information deemed relevant by the Committee.

iv. Recommending the hiring of technical staff or any other such staff which may be deemed appropriate for the purpose of the committee;
