### THE PRESIDENTIAL AND PARLIAMENTARY ELECTIONS REGULATIONS

#### BY-ELECTION RESULTS—SOUTH MUGIRANGO

IN EXERCISE of the powers conferred by the Constitution of Kenya and the National Assembly and Presidential Elections Act and the Presidential and Parliamentary Elections Regulations, the Interim Independent Electoral Commission certifies that Mr. Nyamweya Manson Oyongo has been declared the winner of the South Mugirango Parliamentary Seat following the by-election held on 10th June, 2010.

The Results of the By-election are as follows:

(a) Valid votes cast for Mr. Nyamweya Manson Oyongo, were (in figures) 14,099, (in words) fourteen thousand and ninety-nine.

(b) Total votes cast against the voters register were (in figures) 33,948, (in words) thirty-three thousand nine hundred and forty-eight. Rejected votes (in figures) 644, (in words) six hundred and forty-four. Total valid votes (in figures) 33,301, (in words) thirty-three thousand three hundred and one.

(c) Votes cast as per each candidate are as indicated in the schedule respectively.

The referendum campaign period within which any person or referendum committee supporting or opposing the referendum question may carry out campaigns to support or oppose the referendum question shall begin on the day on which the referendum question is published and end twenty-four hours before polling day which shall be between 12th May, 2010 and 3rd August, 2010.
