DECLARATION OF BY-ELECTION RESULTS—MATUGA

IN EXERCISE of the powers conferred by the Constitution of Kenya and the National Assembly and Presidential Elections Act (Cap. 7) and the Presidential and Parliamentary Elections Regulations, the Interim Independent Electoral Commission certifies that Chirau Ali Mwakwere has been declared the winner of the Matuga Parliamentary Seat following the by-elections held on 12th July, 2010.

The Results of the By-election are as follows:

- (a) Valid votes cast for Chirau Ali Mwakwere were (in figures) 16,350, (in words) sixteen thousand three hundred and fifty.
- (b) Total votes cast against the voters register were (in figures) 32,895, (in words) thirty-two thousand eight hundred and ninety five. Rejected votes (in figures) 359, (in words) three hundred and fifty nine. Total valid votes (in figures) 32,536, (in words) thirty-two thousand five hundred and thirty six.
- (c) Votes cast as per each candidate are as indicated in the schedule respectively.
