DECLARATION OF BY-ELECTION RESULTS-WAJIR SOUTH

IN EXERCISE of the powers conferred by the Constitution of Kenya, Section 14(2) of the National Assembly and Presidential Elections Act (Cap 7) and Regulation 41(2) (b) of the Presidential and Parliamentary Elections Regulations, the Interim Independent Electoral Commission certifies that Mr .Sirat Mahamud Muhumed has been declared the winner of the Wajir South Parliamentary Seat following the by-elections held on 13th October, 2010.

The Results of the By-elections are as follows:

- (a) Valid Votes cast for Mr. Sirat Mahamud Muhumed were (in figures) 9,643 (in words) Nine Thousand Six Hundred and Forty Three.
- (b) Total Votes cast against the voters register were (in figures) 16,084 (in words) Sixteen Thousand and Eighty Four,
 - (i) Rejected Votes (in figures) 37 (in words) Thirty Seven;
 - (ii) Total Valid Votes (in figures) 16,047 (in words) Sixteen thousand and Forty Seven;
